1. BACKGROUND

JW has a backlog of redundant movables assets which have not been disposed of the storage facilities. This has resulted in overload of storage facilities with limited to no space for other assets. There is an urgent need to offload these assets by a way that is most advantageous to the entity. Failure to offload these assets would result in insufficient space to safekeep assets that have recently been disposed. This service is to ensure the transparent, efficient, and fair disposal of redundant, obsolete, or unserviceable assets

2. SCOPE OF WORK AND / OR SPECIFICATION

The objective of this service is to ensure the transparent, efficient, and fair disposal of redundant, obsolete, or unserviceable assets, a qualified auctioneer shall be appointed to facilitate public auctions under the oversight of the disposal committee. This process will strictly comply with all relevant legislation and internal asset management and disposal policies, aiming to maximize revenue from asset sales while promoting transparency, fairness, and competitiveness. Additionally, the timely removal of disposed assets and accurate updating of asset registers will be prioritized. The scope of work covers the end-to-end management of the auction process, from asset valuation and preparation through to execution, payment collection, and final reporting. CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
