### Floors and offices cleaning.

- All Carpeted areas must be vacuumed daily.
- All non-carpeted areas [ramps, kitchen areas, stairways] must be washed/mopped daily and scrubbed once a week.
- Heavy duty industrial vacuum cleaners, scrubbing machines, etc must be used.

### **1.1.2. Hygiene Services and Consumables**

The FMSP shall provide the hygiene services daily, and in exceptional circumstances as requested by JW, which include but not limited to:

- Provision of all hygiene services and consumables.
- The gathering and disposal of sanitary bins should be well maintained and the waste disposed in a safe and compliant manner. Waste bags should be carried in closed trolleys which will be used to handle the bags quietly during the service process.
- SHE bins should be cleaned and replenished with sanitizers or deodorants at least once in a week.
- The Service Provider shall dispose the bin liner with bio-bag specially meant to carry the sanitary waste so that there can be no chances of spillage during the removal exercise.
- The Service Provider must take all the sanitary waste bags and dispose them in a manner that is not contrary to the environmental laws governing bio-hazardous waste. It is a big offense to dispose of it at a normal dumping point in the city. The waste should be disposed to a registered and approved place of disposal of bio-hazardous waste.

Sanitary bins collection and management (maintenance, Safe and compliant disposal of waste) refuse bags to be placed in enclosed trolleys for conveying in a discreet manner throughout the service of sanitary bins.

The service provider must provide approved sanitary disposals, as per the schedule above and/or as and when required and always ensure stock availability.

## CONSENT TO PROCESS PERSONAL INFORMATION IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT, NO. 4 OF 2013 (POPIA)
