## **1. PURPOSE**

The purpose of this exercise is to appoint a service provider for the provision of an electronic information system that will provide access to individual/company, property, documents, credit bureau and vehicle information searches for the ethics and fraud management unit of the South African National Parks for a period of 3 years.

## **2. BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under the National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are guided by its vision and mission statements. As a public entity, the organisation is committed to acting in pursuance of the transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## **3. SCOPE OF WORK**

The Service Provider will be required to provide an electronic information system that will provide access to individual/company, property, documents, credit bureau and vehicle information searches including support and maintenance for the ethics and fraud management unit of the South African National Parks for a period of 3 years.

#### 4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply with requirements as stipulated below:
