1. To give effect to the requirements of the Western Cape Provincial Treasury Instructions, 2019: Supply Chain Management (Goods and Services), Public Finance Management Act (PFMA) Supply Chain Management (SCM) Instruction No. 3 of 2021/2022 - SBD 4 Declaration of Interest, Section 4 (1)(b)(iii) of the Competition Act No. 89 of 1998 as amended together with its associated regulations, the Prevention and Combating of Corrupt Activities Act No 12 of 2004 and regulations pertaining to the tender defaulters register, Paragraph 16A9 of the National Treasury Regulations and/or any other applicable legislation.

"Corruption"- General offences of corruption are defined in the Combating of Corrupt Activities Act, 2004 (Act No 12 of 2004) as:

Any person who directly or indirectly -

- (a) accepts or agrees or offers to accept an! gratification from any other person, whether for the benefit of himself or herself or for the benefit of another person; or
- (b) gives or agrees or offers to give to any other person any gratification, whether for the benefit of that other person or for the benefit of another person., in order to act personally or by influencing another person so to act, in a manner—
 - (i) that amounts to the-
 - (aa) illegal. dishonest. unauthorised. incomplete. or biased: or
 - (bb) misuse or selling of information or material acquired in the course of the exercise, carrying out or performance of any powers, duties or functions arising out of a constitutional, statutory, contractual or any other legal obligation:
 - (ii) that amounts to-
 - (aa) the abuse of a position of authority;
 - (bb) a breach of trust; or
 - (cc) the violation of a legal duty or a set of rules;
 - (iii) designed to achieve an unjustified result; or

- (a) partner in marriage or civil union according to legislation;
- (b) partner in a customary union according to indigenous law; or
- (c) partner with whom he or she cohabits and who is publicly acknowledged by the person as his or her life partner or permanent companion.

8. Any legal person, or their family members, may make an offer or offers in terms of this invitation to bid. In view of potential conflict of interest, in the event that the resulting bid, or part thereof, be awarded to family members of persons employed by an organ of state, it is required that the bidder or his/her authorised representative declare his/her position in relation to the evaluating/adjudicating authority where the bidder is employed by the Institution.
9. The bid of any bidder may be disregarded if that bidder or any of its directors abused the institution's supply chain management system; committed fraud or any other improper conduct in relation to such system; disclosure is found not to be true and complete; or failed to perform on any previous contract.
10. Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). Collusive bidding is a per se prohibition meaning that it cannot be justified under any grounds.
11. Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorises accounting officers and accounting authorities to:
 - a) disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b) cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

1. INTRODUCTION

Service providers with a thorough knowledge and experience of the agricultural sector and with relevant expertise and experience in publishing technical off-the-shelf magazines, are herewith invited to submit bids to undertake the all-inclusive publishing of twelve (12) editions of the AgriProbe, a quarterly popular/semi-scientific magazine of the WCDoA over a three (3) year period.

2. BACKGROUND

- 2.1 AgriProbe is a quarterly popular/semi-scientific magazine of the WCDoA of which all the written content is produced internally. The magazine consists of two sections – one-part popular agriculture related articles and another part sharing research results in the form of semi-scientific articles, known as the Elsenburg Journal.
- 2.2 AgriProbe has a print-run of 7 000 copies per edition of which approximately 3 500 is posted and 3 500 hand delivered. Its readership is mainly based in the Western Cape, but because subscription is free of charge, a portion of the readers are also outside of the provincial borders. The target audience is mainly farmers: commercial and smallholder, agri workers, people working in the agricultural sector, citizens and government officials.
- 2.3 All articles are written by employees of the Western Cape Department of Agriculture and in its popular section it covers articles ranging from events, news snippets, and people on the move, human capital development and economic news to taking our services out there. The Elsenburg Journal comprises of semi-scientific articles focusing on research results in various disciplines.
- 2.4 AgriProbe is also available online through the Department's website (<http://www.elsenburg.com/resource-library/agriprobe>).
- 2.5 AgriProbe is totally funded by the Department and no income is generated from advertisements.

3. SCOPE OF WORK

3.1 GENERAL ADMINISTRATION

- 3.1.2 The publisher will be responsible for the total management of the project – inclusive of final product, supervising the work of a team of specialists which include multiple levels of editors, graphic artists, photographers, printers, distributors etc.
- 3.1.3 The publisher will be responsible for editing all copies (including stories, profiles, and “blurbs”) for grammar and syntax in English, Afrikaans and isiXhosa; work with the editorial committee and correspond with associate editors and contributors to help improve writing and to make articles more powerful.
- 3.1.4 The publisher will be responsible for all layout and graphic designs; design spreads and pages; brainstorm ideas for layouts; work with WCDoA to hone style guide and ensures design is coherent and consistent throughout issue and volume.
- 3.1.5 The publisher will take full responsibility for the printing and will be responsible for liaison with the printing company. The publisher will take full responsibility for the management of the printing process.
- 3.1.6 WCDoA will be responsible for all written content (including headings, photo titles and titles which will be featured on the cover page) and overseeing all aspects of the magazine via its Editorial Committee.
- 3.1.7 WCDoA will be responsible to provide brand elements and to guide the publisher in terms of the brand and brand application.
- 3.1.8 The publisher will meet with WCDoA once the tender has been awarded for a briefing session at Elsenburg (Stellenbosch). This session will include a presentation on the brand of the Western Cape Government by WCDoA.
- 3.1.9 The publisher must attend the four (4) AgriProbe editorial committee meetings per annum at Elsenburg or virtually.
- 3.1.10 Commencement of the contract should be from **November 2024** so that there is sufficient time for hand-over from the current service provider for seamless transition. Work on the March 2025 edition begins in **January 2025** with the first editorial meeting scheduled for **mid-January 2025**.

4. PROCESS

4.1 TIMELINES

- 4.1.1 The publisher will compile a production timeframe (outlining processes and deadlines) in collaboration with WCDoA six months in advance (6-month rolling plan – submitted as a full presentation) that includes all editorial meetings, author's corrections (at least 2 sets); submission of articles to publisher, sub-editing, proofs, production, print and delivery.

- 4.1.2 WCDoA will provide the publisher with dates of editorial meetings to filter into the timeframe.

The project will span over a 3-year period with the first edition due on the 15th of March 2025 and the last edition due on the 15th of December 2027. A total of twelve (12) editions must be produced. The remainder must be delivered to Elsenburg (Stellenbosch region). **IMPORTANT:** Although bidders must quote for up to 3 500 copies to be packaged and posted, the successful bidder must invoice actual copies packaged and posted.
- 5.2 Currently, approximately 3 500 copies are posted, but the Department may increase or decrease the numbers due to circumstances that may arise. If this number should increase, an expansion of the contract will be negotiated with the successful bidder in accordance with SCM regulations.

6. LAY OUT AND PRODUCTION

- 6.1 The publisher will be responsible for the sub-editing (proofread).
- 6.2 The publisher will source relevant pictures [scalable images (vector) and/or photos - including stock photos] where need be at no additional cost. The publisher must also have access to agricultural and agricultural related stock imagery. These images must be sent in both high- and low-resolution versions in a separate file to the Department once publication has been wrapped up for use by the Department in other mediums (the Department will credit photographers where due).
- 6.3 The publisher will design tables, graphs, infographics or any other visual art required to complement the content and all designs must be in a scalable format (vector).
- 6.4 The publisher will design internal advertisements relating to AgriProbe content where need be. A copy will be provided.
- 6.5 The publisher will create QR codes for articles where it is needed and live link these QR codes in the web-friendly PDF version.

- 6.6 The publisher will design (in 300dpi) and layout according to the agreed creative and editorial style in line with the brand of the WCDoA and WCGov.
- 6.7 The publisher will be responsible for the design of the cover page either in terms of conceptual artwork or photography (of which the image may or may not be provided by WCDoA). Conceptual artworks may include scalable imagery, photo-manipulated imagery and/or 3D models to achieve to desired look.
- 6.8 The publisher must submit a web-friendly version (RGB converted version) of the publication on the same day that the publication is ready to go to print. The desired web-friendly version must be at 200dpi and exported with full interactive experience.
- 6.9 The publisher must include, where necessary, multimedia to the web-friendly version of the publication. The media should include but not limited to include video and voice recordings.
- 6.10 The publisher must be able to assist the Department with JavaScript additions to the web-friendly PDF where needed.
- 6.11 The publisher must submit a web-friendly version of the cover page to the Department to be used in social media once the design of the magazine is complete and signed-off by the Department.
- 6.12 The publisher must link all articles to the index of the web-friendly version, so that users may click and scroll to the correct page referenced.
- 6.13 The publisher must provide WCDoA with the open files of the magazine on the same day that the publication is delivered. The open files must be made available in InDesign and must include all vectors and any other stock images that were sourced for the edition. All open files must be delivered as a standard InDesign file with supporting files archived in folders underneath.
- 6.14 WCDoA reserves all rights of both the content, vector files and the photographic images, unless images were sourced whereby, the Department will give credit should said images be used in other mediums.
- 6.15 The Publisher is prohibited from distributing any content or images used in the publication to a third party, except where images were sourced or where approval has been granted by WCDoA in writing. In the case of latter, the WCDoA must be acknowledged.
- 6.16 The Publisher will send print-ready files (in full production quality and in CMYK) to the printer (if outsourced) and will manage the printing process in terms of plot and delivery.
- 6.17 The Publisher will ensure that the AgriProbe is digitally available for easy access, free of charge to the Department's stakeholders and the public.

- 6.18 None of the business requirements as stipulated below may be outsourced, except for printing, packaging and distribution.

7. **APPROVALS**

- 7.1 The Publisher is to send two proofs of copy only, followed by two proofs of full publication including copy and artwork to WCDoA to allow for feedback, corrections and final sign-off. All four proofs must be aligned with the production schedule.

8. **PRINTING AND DELIVERY**

- 8.1 12 x 7 000 copies of 68 page (incl. 4-page cover 200 gsm gloss) Jumbo A5 (240 x 168 mm portrait); cover (200gsm gloss), text paper (100gsm gloss) full colour, saddle stitched publication printed on environmentally friendly paper (not necessarily certified or branded as such).
- 8.2 If the publisher does not have an in-house printing facility, they must source this service from a reputable printer with a good track record which delivers superior quality products.
- 8.3 The printing service provider must be in 100km of the head office.
- 8.4 If printing services are outsourced, the publisher must disclose the name of the preferred printer and its location in the tender documents. The printer details must also include relevant reference contacts for verification of credibility.
- 8.5 Publisher will be responsible for all aspects of printing, including the following:
- 8.5.1 Brief printers in terms of specifications.
- 8.5.2 Send pdf ready files of magazine to printer after approval by WCDoA;
- 8.5.3 Colour proofing.
- 8.5.4 Quality control.
- 8.5.5 Confirm the delivery address with the printers.
- 8.5.6 Ensure the timely delivery of the publications to the mailing house on a date as agreed upon with WCDoA, and
- 8.5.7 Ensure the timely delivery of the publications to Elsenburg on a date as agreed upon with WCDoA.
- 8.6 WCDoA will approve/sign off on the plot, which is received from the printers before print. If a re-print is requested from WCDoA based on content that has changed after approval, a cost will be obtained for WCDoA's consideration. If a re-print is required due to a printer error or an error on the part of the publisher, the printer and/or publisher must carry the costs.
- 8.7 WCDoA will provide the publishers with delivery deadlines which must be factored into the production timeline.

- 8.8 WCDa will provide a list of names and postal addresses of copies per edition to be posted.
- 8.9 The Publisher must ensure that the remainder of copies per edition be delivered to Elsenburg (Muldersvlei Road), Stellenbosch Region.
- 8.10 The Publisher must ensure that up to 3 500 copies per edition are packaged (labour and packaging material) and posted.
- 8.11 **IMPORTANT:** The Publisher must make use of an organisation in Stellenbosch providing work to disabled adults to do the packaging and posting as part of the Department's corporate social investment portfolio. Details and contact of the organisation are as follows:

9. **SERVICE LEVEL AGREEMENT**

- 9.1 A service level agreement (SLA) will be drawn up detailing all contractual obligations between WCDa and the appointed Professional Service Provider (PSP). The service level agreement will specify, inter alia, the agreed deliverables and roles and responsibilities of all parties with timelines of the various parties.

10. **COMPETENCIES, EXPERTISE AND QUALIFICATIONS OF THE SERVICE PROVIDER**

The successful service provider must be:

- 10.1 A technically advanced publishing company which understands agricultural research and technology and specific agricultural disciplines like veterinary services, etc. – both content and technical language.
- 10.2 A publishing company who can do editing of semi-scientific papers in the Elsenburg Journal comprising of articles sharing research results – with very specific technical requirements in both English and Afrikaans.
- 10.3 A publishing company who is operating in the agricultural environment as Agriprobe is slotting in on a level of a popular journal in agriculture.
- 10.4 A publishing company who has access to stock photos/vectors/other visual material in agriculture at no additional cost and can also generate graphs, infographics, illustrations etc.
- 10.5 A publishing company that can independently design arresting conceptual or graphic magazine content and covers.
- 10.6 A publishing company that fully understands layout and design, and uses professional raster, vector and layout software to achieve this goal.

- 10.7 A publishing company who can take Agriprobe into a digital platform environment where all interested parties (also the public) can acquire the magazine. The company must have a sound knowledge base of digital platform publishing and evidence in this regard must be provided.
- 10.8 The publishing company must provide the following services to ensure that the magazine is digitalised:
- 10.8.1 Make the magazine available using Flipbook for the page turner look and feel.
 - 10.8.2 Populate/embed the digital magazine with the necessary interactive components e.g., insert videos, voice clips, podcasts or GIFs, convert images into pop ups. This interactive content will be provided by the WCDoA. At least three (not limited to) interactive content must be placed in each edition.
 - 10.8.3 Make content clickable.
 - 10.8.4 Add personalised JavaScript embedded code where necessary for a better digital user experience.
 - 10.8.5 Track readers, per article as well as for the publication as a whole and a report of this to be shared with WCDoA per quarter.
 - 10.8.6 Place the magazine on two electronic news stands, i.e. Magzter and Zinio magazine stands.
- 10.9 A publishing company who can adhere to strict deadlines, as Agriprobe is a quarterly target item of the Department and its programmes.

11. **CONDITION**

- 11.1 The designated project leader of the publisher must have at least an appropriate 3-year B. degree or equivalent qualification in terms of the journalistic industry and at least 5 years' experience in the agricultural publishing field. Proof of this must be included in the bid proposal.

12. **BID PROPOSAL**

Bidding publishing companies must submit a bid proposal listing the following (not dating back further than 5 years):

- 12.1 Introduction.

- 12.6 Proposed timeline for the production of one edition of the magazine,
- 12.7 Awards won and accolades received.

13. **FINANCIAL PROPOSAL**

- 13.1 A total price (VAT inclusive) must be submitted for all 12 editions.
- 13.2 A breakdown of the costs for each edition must also be submitted including publishing, design and editing, project management, printing, distribution (postage and delivery) etc.
- 13.3 Payments for each edition will only be made on receipt of invoice which must coincide with the delivery of the magazine. Work can commence once an order number has been received from WCDoA.
- 13.4 Bidding publishing companies must be registered on the Central Database and must have a valid tax status.

14. **ADJUDICATION OF PROPOSALS**

- 14.1 Proposals will be evaluated in three phases. In the **first phase**, the bid documents and conditions of the bid will be evaluated and only those prospective service providers conforming to all conditions will migrate to the second phase.
- 14.2 In the **second phase**, all bidders conforming to section 12 above will be evaluated and all bidders will be invited to do a presentation in person to an appointed evaluation committee of the Department. - 14.3 Qualifying bidders' financial proposals will be evaluated as the **third phase**. The 80/20 Preference Procurement Point System for price and preference is applicable after the minimum Functionality Threshold scores have been achieved.

GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT

July 2010

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 “Day” means calendar day.
 - 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order.
 - 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
 - 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of

origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance,

training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

- 1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

- 5.1 The supplier shall not, without the purchaser’s prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier’s performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier’s records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights

arising from use of the goods or any part thereof by the purchaser.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual

- (d) for each appropriate unit of the supplied goods; performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s)

within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in

terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

	(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
29. Governing language	29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law	30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31. Notices	31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
32. Taxes and duties	32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country. 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser. 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
33. National Industrial Participation Programme (NIP)	33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
34 Prohibition of Restrictive practices	In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging). 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
