

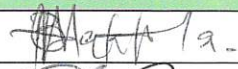
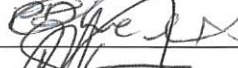

1. PURPOSE

- 1.1** To seek approval to appoint Arena Holdings, Media24 and Vuk'uzenzele for the placement of the Aliwal Shoal Public Notice according to Supply Chain Management Delegation requirements (4.1) in line with National Treasury instruction note no 3 of 2021/22

2. BACKGROUND

- 2.1** The Department of Forestry, Fisheries, and the Environment is embarking on a public consultation process for the proposed extension of the False Bay White Shark Cage Diving (WSCD) operating area. The proposal was published by the Minister of Forestry, Fisheries and the Environment, Ms Barbara Dallas Creecy, for public comment on 2 September 2022 in Government Gazette 46847.
- 2.2** The reason for the proposed extended area is to provide support to the White Shark Cage Diving sector in False Bay which has seen a significant decline in their business operations resulting from the current disappearance of Great White Shark sightings at Seal Island and the increased presence of other shark species (such as the Bronze Whaler) in inshore areas near Strandfontein Beach. The decrease in Great White Shark sightings has also negatively affected the tourism sector in Cape Town as tourism businesses are inherently linked to WSCD tourism activities have also been greatly impacted, such as B&Bs, hotels, restaurants, and tourism businesses.
- 2.3** The proposal is, therefore, to temporarily mitigate the negative impacts on the tourism sector in Cape Town, by extending the area of operation closer to the inshore area where other shark species are found, thus allowing the WSCD operators to continue operating by diving with other shark species.

- 2.4** The proposal is to allow the cage diving operators to attract and utilize other shark species such as the Bronze Whaler's in the newly extended area using chum and other methods.

- 6.2.1** In order to reach the selected target audiences and deliver on the campaign's objectives, Media Buying recommends the use of daily and weekly national newspapers that are relevant to the campaign's objectives and target audience.

- 6.2.2** The recommended daily newspaper are Sowetan with 629 000 readers, Sunday Times with 2 742 000 readers (**Arena Holdings**) and City Press with 1 552 000 readers (**Media24**). Not Recommended daily

- 6.2.4 **Daily Sun** and **Isolezwe** are not recommended because these newspapers are not relevant to the campaign's target market. Daily Sun is a tabloid newspaper with more focus on entertainment and Isolezwe is a regional newspaper whereas we have recommended the use of national newspapers with the aim of reaching a national audience.

- 6.2.5 **Soccer Laduma** is a soccer newspaper and not relevant to the objectives of the campaign. **Sunday Sun** has been discontinued. **Source: PAMS191 PAMS 2019**

- Proposed amendments to the Environmental Impact Assessment Regulations and Listing Notices to facilitate the management and reprocessing of residue stockpiles and deposits and the expansion of mining and production activities. In addition, amendments have been proposed which distinguish between the environmental management programme required in terms of the National Environmental Management Act and the Mineral and Petroleum Resources Development Act.
- A Cape Vulture specialist assessment, which is supported by a risk map, has been developed to further protect Cape Vultures from collisions with wind energy facilities. A Cape Vulture Specialist Assessment, which must be supported by additional monitoring, will be required should the activity of Cape Vultures be confirmed to pose a risk.
- The application process for an environmental authorisation for a renewable energy facility is proposed to be amended by adding the requirement to submit a consent letter from Eskom where the development is proposed within 2km of a main transmission substation or 1km of a main distribution substation. The consent letter is needed to ensure that the positioning of these facilities do not encroach on the substations, thereby limiting connection and resulting in the underutilisation of the infrastructure.
