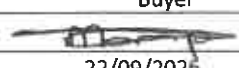
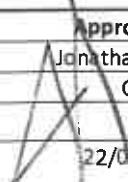

1. PURPOSE

1.1 The purpose of this memorandum is to seek approval for the extension of Acting Chief Executive's protection security services provided by Tyek Security for a period of six (4) months, from 01 July 2026 to 31 October 2026, to ensure the continued safety and protection of the Chief Executive.

2. BACKGROUND

2.1 Amatola Water engaged Tyek Security to provide specialised protection services to the Chief Executive in response to identified risks associated with the position, as well as heightened security concerns that emerged during the 2025 protected labour strike, which necessitated the urgent deployment of armed response personnel.

2.2 The nature of the Chief Executive's responsibilities, which include oversight of strategic operations, stakeholder engagements, and high-level decision-making, necessitates continuous and reliable personal protection services.

2.3 The provision of these services has been instrumental in ensuring the Chief Executive's safety during both official duties and travel to operational sites, some of which are located in highrisk areas.

2.4 The current arrangement is nearing its expiry, and given the ongoing risk environment, it is necessary to extend the service to maintain adequate protection without interruption.

2.5 The extension will ensure continuity of service while the organisation continues to assess long-term security requirements for executive protection.

3. DISCUSSION

3.1 Acting Chief Executive's protection services are a critical risk mitigation measure aimed at safeguarding the Acting Chief Executive against potential threats that may arise due to the strategic and public-facing nature of the position.

3.2 The continuation of these services ensures:

- Personal safety and well-being of the Chief Executive
- Stability in leadership and uninterrupted execution of organisational responsibilities
- Reduced exposure to security-related incidents during official engagements and travel

3.3 Discontinuation of protection services may expose the Acting Chief Executive to heightened security risks, which could have broader implications for organisational leadership and governance.

3.4 It is therefore prudent to extend the current services to ensure sustained protection while maintaining operational continuity.

4. RISK IMPLICATIONS

4.1 Failure to extend the executive protection services may result in:

- Increased personal security risk to the Acting Chief Executive
- Potential disruption to organisational operations in the event of a security incident
- Reputational risk to the organisation for not adequately safeguarding its leadership

4.2 The absence of structured and professional protection services may also lead to reliance on ad hoc security measures, which may not provide adequate risk mitigation.

5. FINANCIAL IMPLICATIONS

5.1 The extension of services will require allocation of funds to cover the cost of executive protection services for the four-month period from 01 July 2026 to 31 October 2026.

5.2 The required funding for the period 01 July 2026 to 31 October 2026 is calculated as follows:
