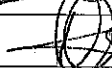
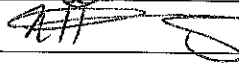

1. PURPOSE

- 1.1 To seek approval to appoint Arena Holdings and Media24 for the Department of Justice and Constitutional Development (Information Regulator) – Recruitment advert campaign according to Supply Chain Management delegations (4.1).

2. BACKGROUND

- 2.1 The Department of Justice and Constitutional Development (Information Regulator) has vacant posts within their department. It is within this background that the DOJ&CD has requested the Government Communication and Information System (GCIS) to assist with the media buying of the recruitment advertisement.

3. CAMPAIGN OBJECTIVES

- 3.1 To invite eligible candidates to apply.

4. TARGET MARKET

- 4.1 Eligible candidates
4.2 Government Segmentation Model (GSM): Rooted Realists, City Seekers, Safely Suburban, Metro Mobiles and Cosmopolitan Capital.

5. CAMPAIGN PERIOD

- 5.1 30 April 2023

6. RECOMMENDATION

- 6.1 Based on the campaign requirements and research analysis conducted, Media Buying recommends the use of Print newspapers with a readership of 21,511,000. Source: Establishment Survey 2019AB.

To seek approval to appoint Arena Holdings and Media24 for the Department of Justice and Constitutional Development (Information Regulator).

NOT RECOMMENDED

- 6.2 **Out of Home (OOH)** reaches 40,715,000 audiences, Television viewership is 39,739 000, Radio listenership is 37,747,000, and Digital audience is 28,421,000. *Source: Establishment Survey 2019AB.*
- 6.3 **Although these media types have a higher reach than print, however they will not be utilised, as these mediums do not offer placement for large content, and are not ideal for recruitment purposes.**
- 6.4 **Delegation 4.1 Print Threshold R3 000 000.00. The campaign total is R 163 254.00 including VAT.**

RECOMMENDED WEEKLY

- 6.4.1 In order to reach the target audience and deliver on the campaign objectives, **Arena Holdings (Sunday Times) and Media24 (City Press/Rapport Combo)** are recommended for this placement.
- 6.4.2 **Sunday Times** has a readership of 2,742,000 which will effectively reach the target market nationally and meet the campaign's objectives. *Source: PAMS 2019 survey.*
- 6.4.3 **City Press/Rapport Combo** has a readership of 2 263 000 which will effectively reach the potential candidates nationally and meet the client's objectives. *Source: PAMS 2019 survey.*

It should be noted that currently media owners do not offer discounts for recruitment placements. Recruitment rates are less than those of the main body rates.

NOT RECOMMENDED WEEKLIES

- 6.4.4 **Soccer Laduma** has the highest readership amongst weekly publications however, it is not recommended for this campaign as it is biased to soccer/football followers and does not offer a recruitment and job seekers section.
- 6.4.5 **Sunday Sun** has been discontinued. Other weekly publications were not recommended as they have a lower readership compared to the recommended publications.
- 6.4.6 **Vuk'uzenzele** is not recommended as the distribution date has already passed on 26 April 2023 and the next distribution date will be on 09 May 2023.
- 6.4.7 **Community print** poses challenges with the lead time due to the urgency of the recruitment placements and the closing dates of the adverts which have to be aligned with one submitted on the DPSA vacancies by the departments. The reason being that the community publications print weekly/bi-weekly/monthly, the booking deadline is 5 – 7 days prior to printing and most of our recruitment adverts are placed on a weekly basis.

- 7.2 The total cost for this placement is **R 163 254.00** which is broken down as per below.

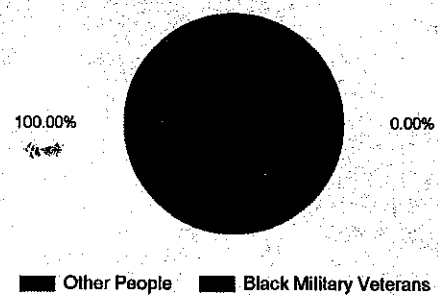
Gender % Ownership



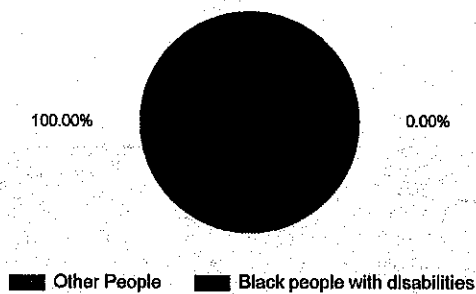
