1. BACKGROUND

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of Section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004).

NERSA's mandate is to regulate the electricity, piped gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), Gas Act, 2001 (Act No. 48 of 2001) and Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

All licence applications submitted to operate a facility must be accompanied by a tariff application which will be considered concurrently to the licence application.

2. SCOPE OF WORK:

The required information for tariff application analysis, approval or setting includes both qualitative and quantitative data and must be in a form that is consistent with NERSA's objectives in so far as tariff principles are concerned and as stipulated in the Petroleum Pipelines Act, 2003 (Act No. 60 of 2003) and Regulations No. 10488, Volume 602 of 28 August 2015 and successor thereto.

Tariff Applications must be done in terms of Rule 12(7) and include the following:

- i) electronic models containing all calculations;
- ii) for pipeline tariffs, all information required in terms of the Energy Regulator's Tariff Methodology for the Petroleum Pipelines Industry to enable the Energy Regulator to set the tariffs for the pipeline;
- iii) for tariffs for storage facilities and loading facilities, proposed tariffs and details regarding the methodology used to determine such tariffs which methodology must comply with the Regulations made in terms of the Act;
- iv) proof or proposed financial security for financial provision for rehabilitation of land made in terms regulation 9 of the Regulations and approved Guidelines on financial provision for rehabilitation of land and
- v) all information necessary to enable the Energy Regulator to apply the Energy Regulator's tariff methodology.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

ANNEXURE 5

Certificate of Independent Bid Determination (SBD 9)

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
- a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

Bid rigging is, therefore, an agreement between competitors not to compete.
