1. BACKGROUND

The South African Diamond & Precious Metals Regulator (SADPMR) is a State Entity that regulates diamonds and precious metals in South Africa. As a State Entity under the Department of Mineral Resources and Energy (DMRE), it is required to annually compile or review its Strategic Plan for the MTEF (Medium Term Expenditure Framework) period, which in this case is the Strategic Plan for FY2020 to FY2025, and its Annual Performance Plan (APP, which in this case is for FY2022-23). These must be submitted to the Minister of Mineral Resources and Energy for approval.

2. PURPOSE OF THE TENDER

The SADPMR requires an independent, neutral facilitator to facilitate and guide the drafting/revising of its Strategic Plan for FY2020- to FY2025 and Annual Performance Plan for FY2022-23 together with Board Members and Management.

3. REQUIREMENTS OF SUCH A FACILITATOR

The Facilitator sought should:

- Have experience in the facilitation of Strategic Plans of Institutions within the mining industry and Regulatory space;
- Be familiar with the National Treasury strategy formulation guideline document for national and provincial departments, constitutional institutions and public entities, viz., *Framework for Strategic Plans and Annual Performance Plans*;
- Ensure Strategic Planning within the relevant timelines;
- Outline expectations and roles of the Facilitator, Management and the Board
- Provide an overview of Facilitation Style
- Provide detailed Strategic Planning method used for facilitation
- Provide a description of the final product after the facilitation process
- Provide referrals of similar sessions conducted within the Mining and Regulatory Sector

The Facilitator sought is expected to:

- Plan the Strategic Session with Management and Board prior to the actual event;
- Provide a framework for the planning process;

- Foster individual and group participation through relevant activities;
- Encourage honest and purposeful communication amongst the groups;
