## **B. REQUEST FOR QUOTATION FOR 100MBPS MICROWAVE/WIRELESS INTERNET CONNECTION-MAITJIESFONTEIN**

### **1. BACKGROUND TO SANSa**

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

## 2. SCOPE OF WORK (TERMS OF REFERENCE)

There is a new ground station, communication facility to be in the Matjiesfontein area in the Western Cape province. SANSA requires the services of a reputable internet services provider (ISP), to provide 100Mbps Microwave/Wireless internet connection at the Matjiesfontein site for a period of 36 months. The connection will be terminated at site office at the Matjiesfontein's Lord Milner Hotel and later moved/extended to the actual site when power and building/site offices has been established.

The service providers **must include** the cost of extending the connection from Lord Milner Hotel, to the site in their submission.

### **Internet requirements:**

Bandwidth: 100Mbps  
Link symmetry: Symmetric  
Availability: >99.5%  
National Latency: <80ms  
Packet loss: <1%  
Jitter: <20ms

### **Maintenance**

The service provider must provide three (3) year maintenance support comprising an average of 12 hours of support per quarter over 12 months. The service provider must be able to restore the service within four (4) hours in case of failure.

The appointed service provider is expected to provide the required service 18 weeks after the PO has been sent.

## C. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below
