The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that not all projects in terms of this quotation may materialise.

Formal quotations will be evaluated in terms of the **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2022), and the Municipality’s Supply Chain Management Policy.
