## ALTERATIONS TO GEORGE HAY PARK ABLUTION

### BOQ BILL OF QUANTITIES

#### NOTES TO PROJECT

THE CONTRACTOR SHALL FULLY COMPLY WITH THE PROVISION OF THE OCCUPATIONAL HEALTH & SAFETY ACT, THE OCCUPATIONAL INJURIES & DISEASES ACT & INSURANCE COVERAGE. APPLICABLE FOR THE WORKS

#### SCOPE OF WORK:

The scope of work measured in this BOQ document in broad terms comprises of the following:

General building, electrical, glazing, plumbing, carpentry, civil, mechanical, fire systems ETC

The anticipated contract period is one (1) month but the contractor must indicate and plan on the period he anticipates to complete all work, the construction works should commence within (7) days of the appointment and issuing of the purchase order, failure to do so will result in penalties and cancellation of the purchase order.

#### GENERAL

- 1 It is recommended that Contractor's inspect the site before pricing this document.
- 2 Quantities of all items are measured nett, and tenderers shall allow in their rates for all necessary cutting & waste & laps etc.
- 3 The Contractor must fully comply with the Insured Safety Plan and must ensure that his rates allow for the requirements contained therein.
- 4 The Physical address of the property is: George Hay Park, Cnr Westmeath rd. and Kildear Ave, Parkview
- 5 The Contractor must note that on signing the Agreement, his builder's lien on the site will be waived. No payment guarantee's will be issued by the Employer.  
Retention will be held on all payments in lieu of a Contractor's performance Guarantee.
- 6 Due to the brevity of descriptions used below, it does not indemnify the Contractor from supplying & installing the relevant items in strict accordance to SANS/Trade specifications and manufacturer's instructions. Any claims in this regard will not be entertained.
- 8 All damaged materials removed are to be carted off site to and deposited at a dumping site located and negotiated by the Contractor at his own cost.
- 9 Where "cart away" (ca) is referred to this will be deemed to include for loading, carting off and dumping on the site as described above
- 10 The Model Preambles for Trades 2008 Edition as published by the Association of South African Quantity Surveyors will apply to this contract.
- 12 The "FORM OF CONTRACT FOR HOUSING AND MINOR WORKS" will be used for this project, JBCC or GCC
- 13 All Prime Cost amounts and Provisional Sums are nett. No discount will be allowed to the Contractor.  
Note: All sub-contractors are direct contractors to the main contractor.
- 14 Where applicable and unless otherwise described, all rates must include for the necessary scaffolding not exceeding 5m high above bearing level AND also for dust screens & tarpaulins etc. where required
- 15 All rates must include for the necessary cutting & waste.
- 16 Profit and Attendance will be adjusted in direct proportion to the final amounts.
- 17 Public liability insurance effected by the Contractor = The Contract Sum + 50% with a deductible amount of Nil.  
Contract's Works insurance = The Contract Sum Plus 20%
- 18 WATER: Water must be provided by the contractor where unavailable at JCPZ sites  
TOILETS: The Contractor must provide his own toilets where unavailable at JCPZ sites  
ELECTRICITY: Electricity used for the work must be metered & paid for by the Contractor but in most cases must be provided by the contractor
- 20 Where material of a hazardous nature has to be removed from site it has to be deposited at a GLB Secure dumpsite, located and negotiated by the contractor and a Safe Disposal Certificate is to be obtained.  
All related fees for this are to be included in the rates.
- 21 **Contract period 1 MONTH FROM SITE HAND OVER, EXCLUDING BUILDERS' HOLIDAYS**
- 22 Penalties for non-completion - **R 1 000.00/day until practical completion is met.**
- 23 The quantities in this document have been measured based on information obtained on site as well as notes provided by the Project managers.  
Should the tenderer think that circumstances have changed since then or if he is of the opinion that items have not been included in this document, he can draw up a specification and submit to the project manager for approval on appointment or during the project, contractors are to not undertake any works outside the scope without written approval by the PM.
- 24 The Successful Contractor must provide a breakdown of his Preliminary & General Cost prior to signing the Agreement and prior to occupying the site.  
The contractor must indicate his costs for: Hire & Maintenance of Portable toilets, Site Establishment, Transport, Telephones, Insurance, Safety & OSH act compliance, Security, Clearing, Cleaning and Handover.
- 25 The Electrical fixtures in the buildings are in place and is on the onus of the appointed service provider to ensure compliance prior to handover
- 25 The plumbing fixtures in the buildings are in place and is on the onus of the appointed service provider to ensure compliance prior to handover
- 26 Contractor to provide all COC's on completion including but not limited to roofing, electrical and plumbing, glazing ETC.  
MATERIALS: Should the work require additional material that are not specified in the schedule of quantities the Contractor must obtain approval from the project manager prior to carrying out the works. The Contractor shall attach to his accounts original supplier's tax invoices for new parts, components and materials to be used or that were used for repair work requiring non-scheduled items, the full description similar to that required to order an item from a supplier, i.e. Make: model, serial number, size, capacity, etc. shall be listed on the account.

The Project Manager reserves the right to:

(a) Supply to the Contractor new parts, components and materials required to undertake repairs, or

(b) The above applies to new parts, components and materials which are to be used for both maintenances, repairs and development works

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
