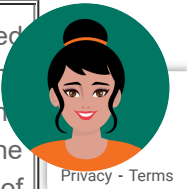

CIDB Regulation 25(1B) will not be applicable to this contract.

Only tenderers with a B-BBEE contributor status level of 1, 2, 3 or 4 and who is an EME or a QSE and who is registered on the National Treasury Central Supplier Database and meets the minimum threshold designated for local production and content as stated in the Tender Data C.2.1. is eligible to tender.

It is estimated that tenderers should have a CIDB contractor grading designation of 4 CE or higher, however tenderers attention is drawn to clause C2.1 of the Tender Data when submitting their tender.

Tenders from tenderers registered as potentially emerging enterprises but with a CIDB contractor grading designation lower than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25(7A) of the Construction Industry Development Regulations, will not be accepted.
