4.3 Documents submitted on time by bidders shall not be returned.

5 LATE BIDS

5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the RAL via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the RAL premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

6 PAYMENTS

6.1 RAL will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the RAL to the Contractor.

6.1.1 The Contractor shall from time to time during the duration of the contract, invoice RAL for the services rendered.

6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as RAL may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to RAL.

6.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

6.2 The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

TERMS OF REFERENCE

1. INTRODUCTION

Roads Agency Limpopo (SOC) Ltd (“RAL”) is a State-Owned Company registered as such in terms of the Companies Act, 71 of 2008 (“Companies Act”), and listed in Schedule 3C of the Public Finance Management Act 1 of 1999 (“PFMA”), whose full ownership and control is vested in the Limpopo Provincial Government, as represented by its nominated shareholder, the Member of Executive Council representing the Limpopo Department of Public Works, Roads and Infrastructure. RAL was established in 2001 by the provincial government, in terms of the Limpopo Province Roads Agency Proprietary Limited and Provincial Roads Act 7 of 1998, as amended, for the sole purpose of carrying out the functions of planning, designing, constructing, maintaining, rehabilitating and managing the provincial road infrastructure network, in its entirety.

In order to provide strategic direction and oversight over the advancement of the business operations of RAL, a Board of Directors has been appointed by the shareholder, whilst for the provision of day-to-day management of the affairs of RAL, a Chief Executive Officer has been appointed, who discharges the duty to manage RAL, with his team of Executive Managers.

In the provision of its strategic leadership and direction and execution of its monitoring and oversight, the Board of Directors is expected to make decisions and take resolutions, based on the available information and/or documentation, which information the individual Directors scrutinises, considers, deliberates on and apply their minds thereto.

In terms of section 20 of the Companies Act, RAL may, in its Memorandum of Incorporation (“Moi”) determine parameters, thresholds, or otherwise limit, restrict or qualify the purpose, powers or activities of RAL, as well as limiting the authority of the Directors (as agents) to perform any act on behalf of RAL (as a principal).

In discharging their duties, performing their functions and exercising their authority, Directors are expected to act in good faith and for a proper purpose, in the best interest of the company, with a certain degree of care, skill and diligence reasonably expected of expected from a reasonable person carrying out the same functions and having the general knowledge, skill and experience.

Section 78 of the Companies Act gives effect to the procurement of Directors and Officers Indemnity Insurance to protect Directors from any liability or expenses for which RAL is permitted to indemnify Directors and Officers.

2. INVITATION

RAL seeks to appoint a suitably qualified, experienced and licenced insurance broker to act as an intermediary for RAL in sourcing insurance covers for Directors and Officers Indemnity Insurance, for a cover validity period of 36 (thirty-six) months.

3. BACKGROUND

The Board of Directors of RAL resolved that it is imperative to procure Directors and Officers Indemnity Insurance (“D&O Insurance”) in order to provide indemnity for any decision made by Directors and Responsible Officers in the execution of their duties.

4. OBJECTIVE

The objective of this engagement is to provide Directors and Officers Insurance policy to cover all past and present Directors of RAL (including independent members of the Audit and Risk Committee) and its Executive Officers (the Chief Executive Officer, Chief Financial Officer, and Company Secretary and all other Responsible Persons that are involved in decision-making processes). A D&O Insurance policy will also frequently cover those who are involved in the management of the company, and sometimes the definition of Insured Person may extend to other employees.

5. SCOPE OF WORK

- Source an insurance cover amounting to R500 million for RAL Directors and Officers Indemnity;
- If cover of R500 million required cannot be obtained from a single insurer, then insurance cover may be obtained from multiple insurers;
- RAL has, at the inception date of the insurance cover(s), total net assets amounting to **R22 340 billion** and a total revenue of around **R2 958 billion** annum, which the board of Directors and Officers oversee (Audited Annual Financial Statements available on request), which must be taken cognisance of;
- Directors and Officers Indemnity Insurance cover a total number of **seventy-six (76)** comprising of past and present directors as well as officers for claims made against them while serving on a board of directors and officers in the employ of the company.
- Provision of cover that extends to any actual or alleged error arising out of a commission or omission, misstatements or decisions made as a result of incorrect or inaccurate information submitted.
- Cover that is inclusive of reimbursement for civil litigations (including the institution thereof or defence thereto, out-of-court settlements, payments in execution of court judgments and legal fees in respect thereof).
