APPOINTMENT OF A FULLY QUALIFIED AND COMPETENT ELECTRICAL CONTRACTOR FOR THE MAINTENANCE AND HANDOVER OF FOUR (4) TRANSFORMERS WITHIN WARD 3

Bidders are hereby invited from suitably qualified service providers for the appointment of a fully qualified and competent electrical contractor for the maintenance and handover of four (4) transformers within ward 3. Only bidders registered with the CIDB in contractor grading designation 2EP or higher will be eligible. In the case of a joint venture, proof of a consolidated CIDB grading designation meeting this requirement shall be submitted.

The physical address for collection of bid documents is Mandeni Municipality's Civic Centre, 2 Kingfisher Road, Mandeni, Cashiers Office, upon payment of a non-refundable fee of **R600.00** (inclusive of VAT). Bid documents will be available from **Wednesday 2nd September 2026 to Tuesday, 15 September 2026** during working hours, **Monday to Friday from 08h00 to 15h30**. Bidders who pay by EFT may request the municipal banking details from the Manager: Supply Chain Management.

A compulsory clarification meeting and site inspection will take place at the Technical Services Boardroom, 2 Croton Place, Mandeni, on **Wednesday, 16 September 2026 at 10h00**, after which bidders will proceed to the sites. Attendance and completion of the attendance certificate are mandatory. Failure to attend the compulsory clarification meeting with the bid document will disqualify the tender. The doors to the venue will be closed at **10h00** and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.

All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
