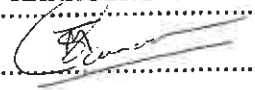

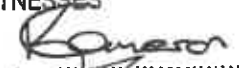

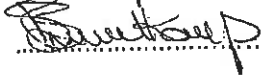

1. Description of Services, Budget and Costing
