Tenders are hereby requested for the **SUPPLY AND INSTALLATION OF FENCING AND GATES AT THE INFORMAL TRADING AREAS, BONNIEVALE AND MONTAGU** as specified in the bid document. Completed Bids, in sealed envelopes, clearly marked “**SUPPLY AND INSTALLATION OF FENCING AND GATES AT THE INFORMAL TRADING AREAS, BONNIEVALE AND MONTAGU**” should be placed in the tender box, at the Langeberg Municipal Office, 28 Main Road, Ashton, not later than **12:00 on 05 NOVEMBER 2021** when the Bids will be opened in public. Late, faxed or e-mailed tenders will not be considered.

PLEASE NOTE:

The official Bid document must be fully completed in black and all pages of tender should be returned preferably bound

Supporting documents must be submitted separately and must be stapled or bound.

Tenderers must be registered with the CIDB in a class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with regulation 25 (7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers will need a grading designation of SQ 1 or higher.

Preferential Procurement Regulations, 2011 (Regulation 9. (1) and 9. (3) make provision for the promotion of local production and content. Local production content applicable to designated sectors of construction.

Only goods, works and services with a stipulated minimum threshold as applicable for local production and content will be considered. The South African Bureau of Standards approved, Technical Specification Number (SATS 1286:2011) will be used to calculate local content.
