- A submission submitted in response to this RFB will constitute a binding offer which will remain binding and irrevocable for a period of **one hundred and twenty (120) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFB validity period is still in force. **(RFB Validity Period: 120 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFB.

INTRODUCTION TO MHSC

The Mine Health and Safety Council (MHSC) is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No. 29 of 1996, as amended. The MHSC is mandated to advise the Minister of the Department of Mineral and Petroleum Resources (DMPR) on mine health and safety (MHS) issues in the mining industry, relating to the development and implementation of the MHSC annual MHS research programme, reviewing and development of MHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve MHS conditions in the South African Mining Industry (SAMI).

South Africa’s mining industry is under pressure to meet its Occupational Health Milestones, set in 2024 to eliminate Occupational Lung Diseases (OLDs) by December 2034 (MHSC, 2014). These targets require that 95% of respirable crystalline silica (RCS) exposure measurements remain below 0.03 mg/m³ and that no new cases of silicosis occur in previously unexposed workers.

Historically, dust control strategies have concentrated on production faces and designated work areas, yet exposures that occur during travel to and from workplaces are often overlooked. Research from SIMRAC GAP 802 “Quantification of dust generation sources in gold and platinum mines” revealed that intake airways—expected to carry clean air—can be significant sources of respirable dust exposure, particularly RCS and coal dust. Workers are unknowingly subjected to dust from vehicular traffic, degraded road surfaces, spillage, ventilation leakages, and maintenance activities along these corridors (SIMRAC, 2003; Stacey et al., 2003).

Cumulative exposures from intake airways contribute to overall occupational exposure profiles, increasing the risk of silicosis, an incurable lung disease that causes permanent disability or death (IARC, 2012). If not urgently addressed through quantification, real-time monitoring, and targeted control measures, these overlooked sources will continue undermining efforts to meet statutory MHS milestones and protect worker health. Identifying

and controlling dust sources in intake airways is therefore critical to breaking the chain of exposure and achieving South Africa's OLDs elimination goals.

CONTEXT OF PROCUREMENT

The MHSC seeks to appoint a service provider to undertake a study to assess and quantify dust contributing sources at the intake airways in South African gold, coal and diamond underground mines.

1. DETAILED SCOPE OF WORK/SPECIFICATIONS

The service provider will be required to undertake the following as part of the scope of work:

- 1.1. Conduct a comprehensive review of local and international literature, including MHSC research project GAP 802, to identify and characterise dust-generating sources contributing to intake airway contamination in gold, coal, diamond and other underground mines.
- 1.2. Identify, profile and quantify the key dust-generating activities, from surface to furthest working places, considering geological factors (e.g. silica content) and operational practices influencing dust generation rates.

- 1.4. Assess worker exposure profiles along travel routes and at key workstations, linking intake airway dust conditions to potential occupational exposure in the following mines: Two (2) gold mines with backfill (mechanised), one (1) gold without backfill (conventional), two (2) coal mines, and two (2) diamond mine.
- 1.5. Apply appropriate modelling techniques (e.g. computational fluid dynamics (CFD) and/or tracer methods, where feasible) to estimate and rank the contribution of identified dust sources to overall intake airway dust loads.
- 1.6. Evaluate existing dust control strategies (e.g. road maintenance, dust suppressants, ventilation optimisation, and traffic management) and, where practical, assess their effectiveness through before-and-after comparisons or scenario-based analysis.

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). MHSC appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
