1. PURPOSE

The purpose of this Request for Proposal (RFP) is to seek proposals from service providers who are Accredited Partners to SAGE VIP System for the Sage VIP Premier Systems in order to migrate to Sage 300 People for the KwaZulu-Natal (KZN) Growth Fund Trust.

2. BACKGROUND

KZN Growth Fund Trust (KGFT) is a fund, established and capitalised by the Provincial Government to provide debt and equity. The main objectives of the KGFT is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KGFT, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KGFT Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KGFT.

The KGFT wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED WORK AND DELIVERABLES

KGFT requires proposals from Service Providers who are accredited and registered as partners with SAGE. The current headcount on the **payroll is 50** and all monthly paid. The number of staff to be trained will be two (02) and there is only One payroll for KGFT.

The services required are as follows.

- Data Migration and Implementation from SAGE VIP Premier to SAGE 300 People

The components of the current payroll system (SAGE VIP Premier) is expected to be upgraded in its entirety and it is expected that the successful bidder has superior knowledge and expertise of the existing product set to facilitate/or produce a well-orchestrated migration plan with itemised catalogue of what was and what will be. Also, where the upgraded technology introduces a significant shift from the existing, these should be clearly documented for appropriate measures to be put in place to mitigate. The modules that are listed below are as listed by the Original Equipment Manufacturer (OEM) and do not take into consideration underlying internal systems objects that may not be known to KGFT. As such, the bidder is expected to take those, if applicable, into consideration in their proposal when responding to the bid.

The Sage VIP Premier Systems upgrade to Sage 300 People project scope of work requires that the service provider perform but not limited to the following:

- The installation and configuration of Sage 300 People should be cost effective and improve the KGFT efficacy.
- For hosting and backup, it is the cloud platforms that will be used, where the following considerations should be accommodated:
- The SAGE Managed Cloud Services should be used to host the environment including hardware through Microsoft Managed Cloud Services.
- The configuration should be extended to workstations or user machines.
- Data migration from existing Sage VIP Premier Systems to Sage 300 People is key and must be done electronically with all the applicable logic embedded in the system, as part of this project.
- Training of the internal HR team on features included in the Sage 300 People system.
- All licensed modules that exist in the current Sage VIP Premier Systems should be configured and implemented in Sage 300 People and new activated where applicable. Below is a list of modules to be implemented at the KGFT:
 - Payroll
 - Leave Management

4.1 Compliance with minimum requirements

All proposal must be accompanied by the following documents:

- 4.1.3 Tax Compliance Status Certificate
- 4.1.4 Provide 3 (three) written letters of reference for similar work performed. Letters must not be older than 3 (three) years
- 4.1.5 The prospective bidder must be a SAGE SA Pty Ltd accredited partner. Proof of accreditation with SAGE SA must be provided in a form of a letter, certificate, etc. for SAGE 300 People and SAGE Premier HR.

Failure to submit any of the above documents will disqualify the bidder from further evaluation. It must be further noted that reference letters will be checked to ensure they relate to the scope of service before moving to Pricing and Specific Goals.

4.2. Price and Specific Goals

4.2.1 Quotations will be subject to an evaluation based on an 80/20 price / specific goals - 80 points for price and 20 points for specific goals as per the below table.

4.2.2 Fixed price quotations are required; price must be inclusive of VAT and all costs relating to disbursements and accommodation.

4.6. I, the undersigned, who is duly authorised to do so on behalf of the company/firm, certify that the points claimed, based on the specific goals as advised in the tender, qualifies the company/ firm for the preference(s) shown and I acknowledge that:

- i) The information furnished is true and correct;
- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;
- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
