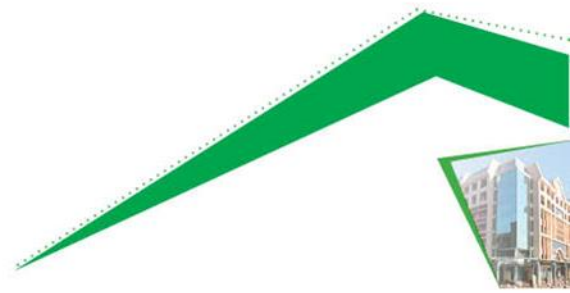

### T1.1 Tender Notice and Invitation to Tender

The Eastern Cape Department Public Works and Infrastructure invites Professional Service Providers for the **PROVISION OF PROFESSIONAL ELECTRICAL ENGINEERING SERVICES FOR THE CONSTRUCTION OF CEBE CLINIC**

Eastern Cape Department of Public Works and Infrastructure will enter into a contract with the successful tenderer.

The contract will be based on the CIDB Professional services contract (Third edition) 2009.

Only tenderers who have suitable experience and suitably qualified personnel in providing similar services to those that are required are eligible to submit tenders.

Bid documents will be emailed to nominated bidders on the **20 July 2022**

### B. BID EVALUATION:

**This bid will be evaluated in Two (2) phases as follows:**

Phase ONE: Compliance, responsiveness to the bid rules and conditions, thereafter (if applicable).

Phase TWO: Bidders passing all stages above will thereafter be evaluated on PPPFA.

It is the responsibility of the bidder/s to ensure that bid documents /proposals are submitted on or before closing time and at the correct location as the department will not take responsibility of wrong delivery.
