1. PURPOSE

- 1.1 To seek approval to appoint Arena Holdings and Media 24 for the placement of the Department of Higher Education and Training Call for Nominations campaign according to Supply Chain Management delegations (4.1) as per SCM instruction no.03 of 2021/22.

2. BACKGROUND

- 2.1 The Minister of Higher Education, Science, and Innovation, DR B E Nzimande invites the public to nominate Ministerial appointees for consideration as council members for forty seven (47) Technical and Vocational Education and Training (TVET) colleges in nine (9) provinces in terms of Sections 10 (4) b of the Continuing Education and Training Act No 16 of 2006 as amended.
- 2.2 A nominee must be a person with knowledge and experience relevant to the objects and governance. The person shall have requisite expertise and experience in public or private institutions and a broad range of competencies in areas such as, but not limited to, governance, finance and audit, management, technical education, business, law, information technology, human resource management, and stakeholder relations.
- 2.3 It is against this background that the DHET has requested the Government Communication Information System (GCIS) Media Buying to assist with the media placement for this advertisement in national weekly publications.

3. CAMPAIGN OBJECTIVES

- 3.1 To invite the public to nominate Ministerial appointees for consideration as members of the TVET Council.

6. RECOMMENDATION

- 6.1 **Based on the campaign requirements and research analysis conducted, Media Buying recommends the use of Print newspapers with a readership of 21,511,000. Media Buying conducts research and identifies the media platforms to use prior to requesting quotations from suppliers.**

NOT RECOMMENDED

- 6.2 Out of Home (OOH) reaches 40,715,000 audiences, Television viewership is 39,739 000 and Radio listenership is 37,747,000. *Source: Establishment survey 2019AB.*
- 6.3 Although these media types have a higher reach than print, however, they will not be utilized, as they do not offer placement for large content, and are not ideal for placement of this recruitment.
- 6.4 **Delegation (4.1) for Print Threshold R 3 000 000.00. The campaign total is R 184 920.00 including VAT.**
 - 6.4.1 To reach the target audience and deliver on the campaign objectives, Arena Holdings (Sunday Times) and Media 24 (City Press/Rapport) are the recommended publications for this placement. It should be noted that the deadline to submit the quotation was not indicated in the email sent to the supplier however, the supplier responded within 5 days. The supplier was not put under duress to respond with a quotation.
 - 6.4.2 Sunday Times offers a total readership of **2 742 000** and City Press/Rapport offers **2263 000** amongst weekly newspapers, which will be eligible to reach the targeted applicants nationally and meet the client's objectives. *Source: PAMS 2019 survey.*

27.8 Million People
(48% of SA adult population)

They are mostly unemployed, with low education levels. Some try to remain positive and acknowledge that they have come a long way.
