The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of CONSULTING ENGINEERING SERVICES FOR THE RESURFACING OF NATIONAL ROUTE R38 SECTION 4 FROM CAROLINA (KM 0.0) TO BADPLAAS (KM 52.6). This project is in the province of Mpumalanga and in the local municipality of Chief Albert Luthuli and the approximate programme is for design and construction documentation to be completed by April 2024, followed by supervision of 16 months, commencing September 2024.

Replace the following sentence:

Only tenderers with a B-BBEE contributor status level of 1, 2, 3 or 4 who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date, are eligible to tender.

Replace with the following:

“Only tenderers who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date, are eligible to tender.”

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
