Formal quotations will be evaluated and adjudicated in terms of the 80/20 Preference Point System prescribed by the Preferential Procurement Policy Framework Act (Act5 of 2011) and the Municipality's Supply Chain Management Policy.

It is a prerequisite that all prospective service providers who are not yet registered on the Western Cape's Central Supplier Database register without delay on the website www.csd.gov.za. **Further Local Content and Production will form part of the evaluation and therefore all potential bidders who fail to meet the minimum threshold for local content will not be considered for award.**
