

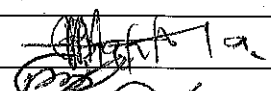
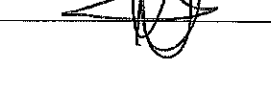

1. PURPOSE

- 1.1** To seek approval to appoint SABC for the placement of the **Relaunch of WOMESA Campaign** according to Supply Chain Management Delegation requirements (4.3) in line with National Treasury instruction note no 3 of 2021/22

2. BACKGROUND

- 2.1** The National Department of Transport will re-launch the South African Chapter of the Association for Women in the Maritime Sector in the Eastern and Southern Africa (WOMESA) in Gqberha in Eastern Cape from 30-31 May 2023.
- 2.2** The purpose of WOMESA is to actively support the advancement of women to managerial positions and higher levels in the maritime sector in East & Southern Africa and thereby strengthening maritime capacity in the region so as to promote safe, secure and efficient shipping on cleaner oceans.
- 2.3** WOMESA is a programme under the International Maritime Organization (IMO), Women in Maritime IMO's Gender Programme initiated in 2007, and launched in 2008 with 5 founding members from Eastern and Southern Africa (South Africa, Kenya, Tanzania, Namibia and Mauritius). The WOMESA Strategic Plan 2008-2013 called for formation of National Chapters.

3. CAMPAIGN OBJECTIVES

- 3.1** To support the advancement of women to managerial positions and higher levels in the maritime sector

To seek approval for appointing SABC for the placement of the **Relaunch of WOMESA**

- 3.2 To educate women about opportunities in the maritime sector
- 3.3 To promote safe, secure and efficient shipping on cleaner oceans

4. TARGET MARKET

- 4.1 Gqberha (Eastern Cape)
- 4.2 Rooted Realists, City Seekers, Safely Suburban, Metro Mobiles and Cosmopolitan Capital as per the attached Government Segmentation Model.

5. CAMPAIGN PERIOD

- 5.1 30 May 2023

6. RECOMMENDATIONS

- 6.1 For the purpose of this campaign and to ensure that the campaign is effective, Media Buying recommends the use of radio (36 741 000) to help create awareness about the Transport's re-launch of the South African Chapter of the Association for Women in the Maritime Sector. Out of Home and TV are not relevant for this campaign hence they are not recommended. Radio is recommended based on relevance as per the approved Media Buying Standard Operating Procedure (SOP) *Source Establishment Survey 2019 AB (Jan-Dec 2019)*.
- 6.2 **DELEGATION (4.3) ACQUISITION OF RADIO (THRESHOLD R3 000 000.000) CAMPAIGN TOTAL R322 000.00**
 - 6.2.1 Radio is recommended because it is an interactive, intrusive and mobile medium with an ability to reach audiences anywhere at any time and can be accessed through various devices.
 - 6.2.2 For the purpose of this campaign, it should be noted that the campaign will be delivered in the form of an Outside Broadcast (OB) using a regional radio station with the most listeners in the Eastern Cape. The event will broadcast live on radio and discussion points shared with the rest of the listeners in order to create an interaction and discussion setting. The use of Outside Broadcasts assist in taking the brand to the consumer. OB's generate excitement and enthusiasm amongst listeners. They offer the brand and the client an opportunity to interact, be experienced and thus understood by the listeners.
 - 6.2.3 The recommended radio station is Umhlobo Wenene FM (**SABC**) with 2 552 000 listeners. Umhlobo Wenene FM has the highest listenership in the Eastern Cape hence it is recommended. All other radio stations have a lower listenership compared to Umhlobo Wenene FM. **Source: BRC RAMS (February 2022 – January 2023)**.

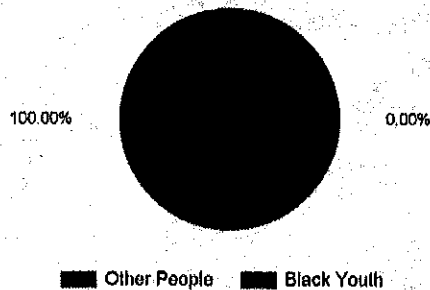
People % Ownership



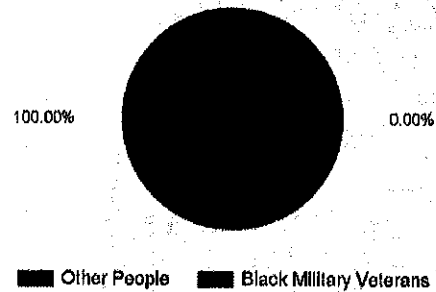
Gender % Ownership



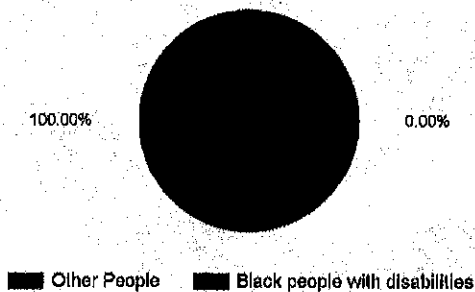

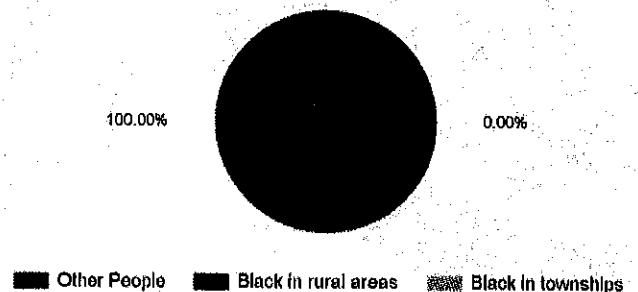

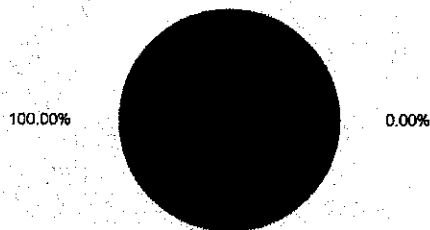
