BIDDERS MUST TAKE NOTE OF THE FOLLOWING:

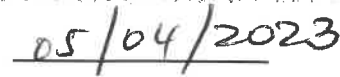
- Bids will be subjected to a two (02) stage evaluation system: Stage 1 – Evaluation on functionality and Stage 2 - Evaluation on price & preference points. The 80/20 preference point system, in terms of the Preferential Procurement Policy Framework Act 5 of 2022 regulations thereto, is applicable to this bid.
- Bidders are required to submit the specified verification documentation to together with their bids to substantiate their preference points scoring.
- Bidders must submit proof of tax compliance with SARS – Tax compliance status pin;
- Bidders must be registered with Central Supplier Database (CSD) and bids from non-registered bidders will be eliminated;
- The bids are subject to an objective criteria as per the bid document
