TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO TRANSPORT SADPMR EMPLOYEES BETWEEN JOHANNESBURG TO KEMPTON PARK FOR PERIOD OF 12 MONTH

1. PURPOSE OF THE ASSIGNMENT

The purpose of the assignment is for the SADPMR to appoint a Service Provider to transport employees from 251 Fox street in Johannesburg to 48 Bonaero Drive in Kempton Park and back. This service will be required from Monday to Friday excluding public holidays, weekends and any other day communicated to service provider by SADPMR.

BACKGROUND

- SADPMR will be relocating from 251 Fox street in Johannesburg to 48 Bonaero Drive in Kempton Park. The entity requires service provider who can transport employees between the above destinations.

2. SCOPE OF WORK AND DELIVERABLES

Service providers are invited to submit quotations for the execution of the following services:

- a. Provision of a minimum 22-seater transport for employees commuting between 251 Fox Street Johannesburg and 48 Bonaero Drive in Kempton Park for a period of twelve months
- b. To pick up employees in the morning at Jewel City, 251 Fox Street, Johannesburg to 48 Bonaero Dr, Kempton Park 1622 (first load 07H00 and second load 08H00 Monday to Friday), and;
- c. Drop off employees in the afternoon from 48 Bonaero Dr, Kempton Park 1622 to Jewel City, 251 Fox Street, Johannesburg (first load 15H30 and second load 16H30, Monday to Fridays).



3. DELIVERABLES

- The successful bidder will be required to timeously pickup and drop off employees between 251 Fox Street Johannesburg and 48 Bonaero Drive in Kempton Park.
- The successful bidder will be expected to comply with covid 19 regulations at all times.
- Service provider will be expected to keep and maintain a daily register of employees utilising transport between 251 Fox Street Johannesburg and 48 Bonaero Drive in Kempton Park. This register will be submitted together with the invoice on a monthly basis.
- The successful bidder must be able to commence with the execution of the required services from 01 September 2021.

4. EVALUATION METHODOLOGY

Cost

- The service provider will be requested to provide a quote regarding the work to be undertaken for this project. The total cost must be VAT inclusive and should be quoted in South African currency (i.e. Rands). Detailed breakdown of the total bid must be attached.

Broad-Based Black Economic Empowerment (B-BBEE)

- Provisions of the Preferential Procurement Policy Framework Act (PPPFA) 2017 and its regulation will apply in terms of awarding points.
- Bidders are required to submit original and valid B-BBEE status level Verification to substantiate their B-BBEE rating claims.
- Bidders who do not submit their B-BBEE status level verification certificates or are non-compliant contributors to B-BBEE will not qualify for preference points for B-BBEE.
- In a case of Exempted Micro Enterprise (EMEs), AO/AA must ensure that the B-BBEE Status Level Verification Certificates submitted are issued by the following agencies:
 1. Verification agencies accredited by SANAS; or
 2. Registered auditors approved by IRBA
