Detailed Specifications for the Supply and Installation for Vehicle Tracking Devices for A Period of Thirty Six (36) Months

1. Purpose

South African Local Government Association (SALGA) would like to request for proposals from the service providers to supply and install vehicle tracking devices for a period of 36 months.

2. Background and Basic Requirements

SALGA has four vehicles as follows: two mini buses, one light delivery van and luxury sedan vehicle. The service provider will be expected to make provision to add tracking devices should SALGA procure new vehicles to be linked with the remainder of the 36 months period.

In case where the vehicle is disposed of or written off, the service provider will be expected to discontinue the tracking device without penalty prior to the expiry of 36 months period.

3. Experience and References

A minimum of 5 years of experience and 3 three letters of references with contacts of persons where similar service was or currently rendered will be required.

4. Reports and Performance Reviews in Line With Service Level Agreements (SLA)

SALGA should be able to generate real time report using service portal / web-based system assigned to SALGA Administrator as and when required. The SLA will be entered into between SALGA and successful service provider. Quarterly contract performance reviews to be conducted in line with SLA.

5. Implementation Plan

The service provider should include in the proposal the implementation plan, how the installation will be conducted, estimated duration or time frames given the number of vehicles provided. Quotation must include once off installation cost, monthly costs and the overall total.

6. General Requirements

- Device Compatibility: Suitable for company fleet vehicles (cars, light delivery vans, and mini buses vehicles)
- Real-Time Tracking: Real-time GPS tracking with web-based and mobile app access

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
