T1.1 : TENDER NOTICE AND INVITATION TO TENDER

Tenders are hereby invited for contract no: NC065/T10/2024 for the replacement of high mast light fittings in Brandvlei, Calvinia, Loeriesfontein and Nieuwoudtville.

Only bidders who satisfy the eligibility criteria stated in the Standard Conditions of Bid (Clause C.2.1) are eligible to submit tenders.

Tenderers must be registered with the CIDB in an **EP** class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with regulation 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers will need a grading designation of **4EP or higher**.

Contractors registered as potentially emerging enterprises with the CIDB who are registered in one contractor grading designation lower than that required in terms of the requirement above and who satisfy all other Eligibility Criteria in terms of this Tender, may submit tender offers.

Tender Documents will also be available at the compulsory site inspection. Prospective tenderers need to inform Mr. Theo Potgieter should they require a printed document at the compulsory site inspection.

Duly completed tenders in sealed envelopes marked "TENDER NC065/T10/2024: ENERGY EFFICIENT INTERVENTIONS IN HANTAM MUNICIPAL AREA (2024/25)", together with the name and address of the Tenderer must be placed in the tender box, Municipal Offices, 20 Dr Nelson Mandela Drive, Calvinia before 12:00 on **Tuesday 2 JULY 2024**, upon which the tenders will be made public.

A **compulsory clarification meeting** with representatives of the Employer will take place at the Municipal Offices of Hantam Municipality in **Calvinia**, 20 Nelson Mandela Drive, Calvinia on **Thursday 20 June 2024**, at **14:00**.

Late tenders will not be accepted and the Municipality will not be compelled to accept the lowest or any tender. The Municipality reserves the right to omit any part of the tender, or to scale down on the scope of work for the contract amount to fit into the available budget. Tenders by telephone, facsimile and e-mail will not be accepted.

All bids received shall be evaluated in terms of the Hantam Municipality's Supply Chain Management Policy and Preferential Procurement Regulations. It is estimated that the 80/20 preference points system will be applicable. Tenders will be evaluated in terms of price and preference.

The Hantam Municipality endorses and supports the Government's Black Economic Empowerment Programme and is committed to rectify the inequalities of the past. For bidders to qualify for the advantages of the B-BBEE Act, they must thoroughly complete the attached Annexure MBD 6.1. There will be no benefits if the schedule is not thoroughly completed. Preference points **MUST** also be claimed in paragraph 6.1. Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates or certified copies thereof together with their bids, to substantiate their B-BBEE rating claims. Bidders are also required to submit Proof of Locality in order to claim points for locality.
