



## **TENDER NOTICE AND INVITATION TO BID**

### **EXPRESSION OF INTEREST:**

**SUPPLY & INSTALLATION OF FENCING TO VARIOUS FACILITIES THROUGHOUT SOUTH AFRICA  
(FRAMEWORK AGREEMENTS)**

**CONTRACT NO. CDC/08/22**

*The Coega Development Corporation (CDC) is headquartered in the City of Gqeberha, Nelson Mandela Bay Municipality, South Africa, with a strategic operational footprint in South Africa and beyond the borders in the African continent. The CDC's vision is to be the leading catalyst for the championing of socio-economic development. This it seeks to achieve through the development and operation of the 9 003-hectare Coega Special Economic Zone (SEZ), a transshipment hub and a leading investment destination in Africa, providing highly skilled competence and capacity for the execution of quality complex infrastructure and related projects throughout South Africa and selected markets on the African continent, and advisory on the development of industrialization and logistics zones. The CDC's advanced capabilities are successful enablers in economic zone development and management, real assets management, infrastructure planning and development for National, Provincial, Local Government Departments and State-owned Entities, technology integration while realising related socio-economic impact areas such as skills and SMME development. The foundational culture of the CDC's approach, backed by core values, is innovation and continuous improvement.*

### **INVITATION TO TENDER**

The CDC is inviting capable and competent Service Providers to submit an Expression of Interest (Eoi) to enter into Framework Agreements for the Supply Only (in case of Suppliers) and Supply & Installation or Installation Only (in case of a Contractor) of various types of security fencing to various facilities throughout South Africa.

### **SCOPE OF SERVICES**

The scope of work entails supply and installation of security fencing to various facilities. The following types of fencing will be used:

- (a) Galvanised Wire Fence and gated;
- (b) Standard Steel Wire Mesh Fence and gates;

- (c) Steel Palisade Fence and gates;
- (d) Steel Mesh Medium Fence and gates;
- (e) Low Security Steel Mesh Fence and swing and sliding gates;
- (f) Medium Security Steel Mesh Fence and swing and sliding gates;
- (g) High Security Steel Mesh Fence and swing and sliding gates;
- (h) Electrical Gate Openers (Gate Motors).

The scope for the projects will include but not limited to conducting physical site assessments, demolition of old existing fences, gates and other minor works, installation of fence to existing infrastructure. It will further include all the processes involved in bringing about the successful completion of the projects to Clients' standards and industry best practices.

**NB: Bidders are to select Part A of the Pricing Schedule if you are a Supplier Only and Part B if you are a Contractor for Supply & Install and Install Only. A bidder may tender for both, if they qualify and meet both criteria.**

### **CONDITIONS**

- (a) The CDC's Procurement Policy and Procedures shall apply.
- (b) The following legislation shall apply:
  - (i) Public Finance Management Act (Act No. 1 of 1999) (PFMA).
  - (ii) National Treasury Regulations.
  - (iii) Preferential Procurement Policy Framework Act, 2000.
  - (iv) Preferential Procurement Regulations, 2017.
  - (v) Occupational Health and Safety Act and Regulations, Act (85 of 1993).
  - (vi) Compensation for Occupational injuries and disease Act (130 of 1993).
  - (vii) B-BBEE Act Number 53 of 2003 (as amended by Act number 46 of 2013); and
  - (viii) Any other applicable legislation.
- (c) Bidders shall be registered with the Construction Industry Development Board (CIDB) and should have an active CIDB Contractor grading of **3SQ or higher. 2SQ PE and lower are not eligible to bid.** (In a case of a Contractor)
- (d) Bidders shall be compliant with all relevant aspects of **National Building Regulations or SANS 10400 or all requirements for either an appropriate Agrément South Africa certificate or Rationale Design certificate** and relevant Supplier Insurance. (In a case of a Supplier)
- (c) Joint Ventures or Consortia will **NOT** be considered.
- (d) Bidders must confirm their company registration with Companies and Intellectual Property Commission (CIPC) as CDC will not award any bid to any business that appears on the CIPC List of de-registered businesses. The CDC may verify company registration with CIPC through BizPortal.
- (e) Bidders must provide proof of registration on the National Treasury's Central Supplier Database (CSD) or provide a Treasury CSD registration number e.g., MAAA0...
- (f) The CDC will only award the Bid to a Successful Bidder who is tax compliant. The tax compliant status of the Bidder will be verified through the CSD and South African Revenue Services (SARS) website.
- (g) The Financial proposal will be in Rand only. The CDC will not cover exchange rate risks.

- (h) All bid prices must be inclusive of Value-Added Tax or any applicable taxes in the country of origin. Non-VAT vendors who submit bids for contracts that would, if successful, take their annual turnover above the threshold of R 1 million are obliged to include VAT in the prices quoted and must therefore immediately upon award of the contract register with the South African Revenue Service (SARS) as VAT vendors. The award of contract would be conditional pending the successful bidder submitting proof of registration as a VAT vendor with SARS.
- (i) Following the procurement process, the Successful Bidder will be required to comply with the Occupational Health and Safety Act and Regulations, Act (85 of 1993) and Compensation for Occupational injuries and disease Act, Act (130 of 1993) and all relevant and applicable legislations.
- (j) Bidders are required to meet the minimum stipulated threshold for **Local Production and Content as per the dtic designated sector requirements at award stage**, the list of designated for local production with minimum local content thresholds is attached as Annexure F accessible on [http://www.dti.gov.za/industrial\\_development/ip.jsp](http://www.dti.gov.za/industrial_development/ip.jsp) and National Treasury Instruction Note 15 of 2016-2017- Steel Products and Components for Construction) and an extract from the Preferential Procurement Regulations, 2017.
- (k) Should the contract be awarded to a **Grade 7SQ or higher contractor**, the contractor may need to meet the SMME participation target of 33 % of the contract value excluding VAT, contingencies and escalation.
- (l) As per amended construction codes, companies with less than 51% black shareholding (QSEs & Generics) are to submit a valid SANAS Accredited B-BBEE Verification Certificate (with the full applicable B-BBEE elements) QSE with at least 51% or 100% black shareholding and EMEs with an annual turnover of R 3 million are required to submit a B-BBEE verification certificate from a SANAS accredited verification agency as they have to comply with the 40% sub-minimum requirement on the QSE Skills Scorecard to avoid being discounted a level. EMEs with a turnover of less than R3 million are exempt from complying with the subminimum requirement and may submit an affidavit or a certificate issued by CIPC, confirming their ownership and annual turnover.
- (m) Public servants are prohibited from conducting any form of business with organs of state, whether in their own capacity as individuals or through companies in which they are directors. Verification will be carried out by the CDC and Bidders will be disqualified should they be found to be in contravention with this requirement.
- (n) The successful Service Providers will be placed in the CDC's fencing framework system for a period of **36** months with an option to extend for further **24** months, and this framework agreement will be used for urgent and emergency cases as and when required.
- (o) Framework Agreement of pre-qualified Service Providers arising from this EoI process will enable the CDC to procure an entity or entities on an instruction basis over a term upon CDC receiving budget allocation to carry out the work and CIDB grading will determine the value of projects awarded.
- (p) The successful Service Providers will be appointed based on the competitive rates they tendered in response to this EoI process. **The Rates tendered will be fixed for 12 months from closing date of the EOI and will be adjusted after 12 months based on the Haylett formula workgroup 136.**
- (q) **The CDC reserves the right to negotiate rates at any time with the bidders.**

Failure to provide any mandatory information required in this Bid will result in the submissions being deemed null and void and shall be considered non-responsive. Telegraphic, telexed, tippexed, facsimiled or e-mail submissions will not be accepted.
