1. Broadband Infraco standard conditions of purchase shall apply.

3. Late and incomplete submissions will not be accepted.
4. Any bidder who has reasons to believe that the RFQ specification is based on a specific brand must inform Broadband Infraco before the RFQ closing date.
5. Where applicable, Work will be carried out in terms of the OHSA and regulations and therefore it is important for the bidders to include OHSA compliance costs (i.e., safety file for the recommended bidder will be approved by Broadband Infraco).
6. Bidder is required to submit copy of Tax Clearance Certificate and verification information (PIN) to be used by Broadband Infraco to validate the copy on the SARS website for all price quotations exceeding the value of R30 000 (VAT included). Failure to submit the copy of valid Tax Clearance Certificate and verification information will result in the invalidation of this RFQ. 1. SCOPE OF WORK

Supply and install of an air conditioner at the Yzerfontein PoP where one of the new IP core router (NCS 5504) will be deployed. These upgrades consist of the following.

Yzerfontein PoP The following power upgrade will be required as laid out on the below table.

- The new 2 x 3phase inverter type floor standing 48000-60000 BTU air conditioners will be installed to replace the currently installed 2 x 24 000BTU wall mounted split units air conditioners. The 24 000BTU air conditioners to remain BBI property.
- The contractor should supply, delivery and install and commission the tabled items below and should provide all necessary installation material e.g. cabling, piping, circuit breakers, isolating/disconnector switches etc. including any other work/parts to complete the job. The required CoCs will also need to be issued accordingly afterwards.

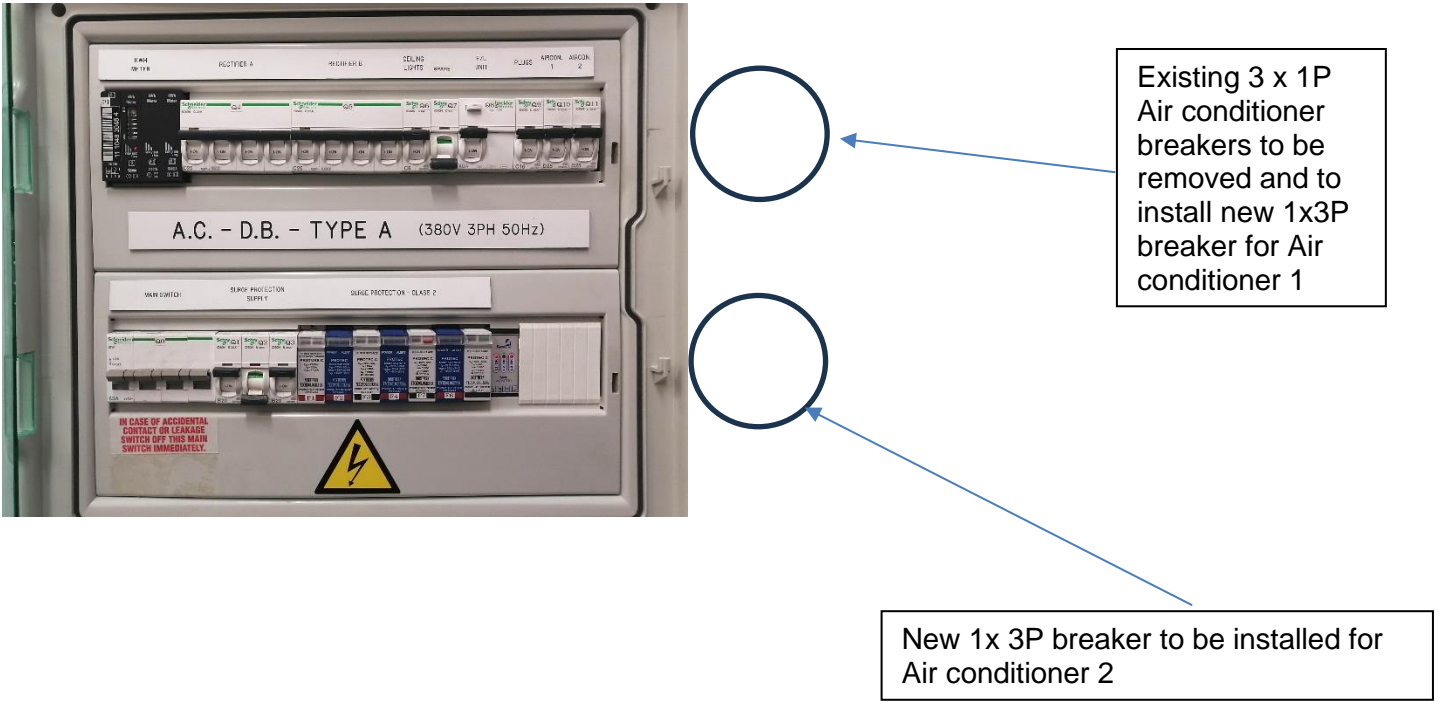


Figure: Existing AC Board

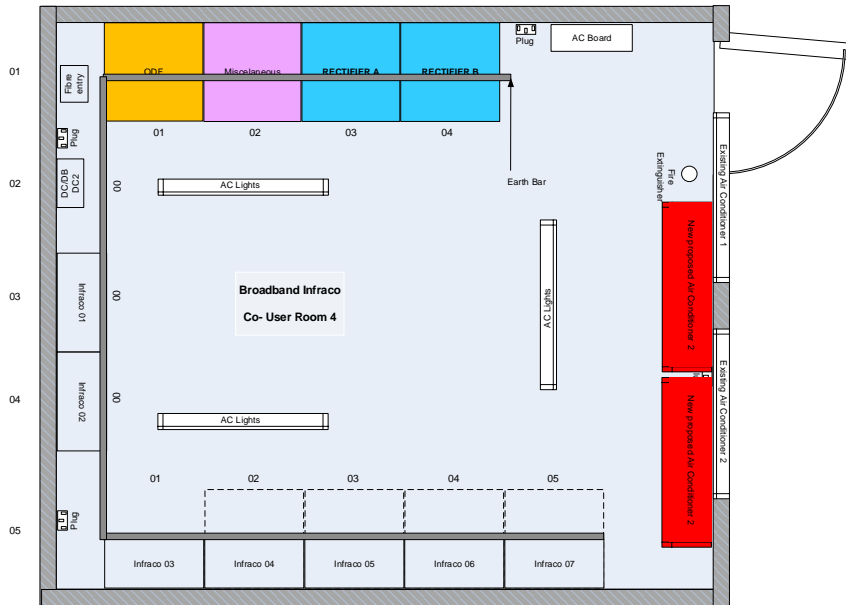


Figure: Room layout and proposed position for the two new Air conditioners
