1. INTRODUCTION AND PURPOSE

Introduction to Ultrahigh Purity Gases

Ultrahigh Purity (UHP) gases are gases that are extremely free from impurities, typically containing 99.999% or higher purity levels. These gases are essential in applications where even minute traces of impurities can have significant adverse effects on processes or products. The need for such high purity arises in various scientific, industrial, and technological fields, where precision, safety, and quality are critical.

UHP gases are commonly used in industries such as semiconductor manufacturing, medical and healthcare applications, environmental monitoring, and research laboratories. The purity of these gases is carefully controlled and maintained during production, transportation, and storage to ensure their effectiveness in the intended applications.

Purpose of Ultrahigh Purity Gases

The primary purpose of UHP gases is to provide gases that are free from contaminants such as water, oil, particulates, and other chemical impurities. Some of the key purposes include:

- Semiconductor Manufacturing: In the production of semiconductor devices, UHP gases are used in processes like chemical vapor deposition (CVD), etching, and cleaning. Contaminants in these gases can damage delicate microchips and electronic circuits, making high-purity gases crucial for ensuring the precision and reliability of these processes.
- 2. **Medical Applications**: UHP gases such as oxygen, nitrogen, and carbon dioxide are used in medical devices, anesthesia, and respiratory therapies. Impurities in these gases could harm patients or interfere with medical treatments, so ensuring their purity is critical for patient safety.

- 3. **Research and Laboratory Work**: In research fields like chemical analysis, spectroscopy, and controlled reactions, UHP gases provide an uncontaminated environment. This ensures accurate experimental results and protects sensitive instruments from damage.
- 4. **Environmental Monitoring**: UHP gases are also used in air quality monitoring and environmental testing. For example, UHP nitrogen is used in calibration standards for atmospheric monitoring equipment to detect pollutants at trace levels.
- 5. **Industrial Applications**: In industries such as food packaging, laser cutting, and welding, UHP gases ensure the integrity of products and processes by preventing oxidation, contamination, or degradation.

In summary, the primary purpose of UHP gases is to support processes where the presence of contaminants could compromise the quality, performance, or safety of the end product or process.

2. BACKGROUND

- Attach Plant and equipment Ownership documents / Letter of arrangements for the leasing of the vehicle/s.

6. CONDITION

- ISO 9001 Certification: This certification ensures that the gas supplier operates under an internationally recognized quality management system, which is critical for UHP gas supply.
- ISO 17025: Laboratories involved in testing and analyzing UHP gases may need this accreditation, particularly if providing calibration and analysis services.
- ISO 13485: If the gases are used in medical or healthcare settings (e.g., medical oxygen), compliance with this standard may be required.

- CGA Grade: The CGA defines gas grades that are applicable to high purity gases (e.g., CGA Grade 4.0 or higher for UHP gases).
- ISO 8573-1: This standard defines the classification of air purity, often relevant for UHP gases used in sensitive applications like semiconductor manufacturing.
- Gas Handling Equipment: Ensure that the company complies with standards regarding storage and transport of compressed and ultrahigh purity gases. This includes the use of proper cylinders, valves, and regulators certified for UHP gas handling.

If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier

to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.
