1. BACKGROUND OF THE COUNCIL FOR MEDICAL SCHEMES

The Council for Medical Schemes is a statutory body established by the Medical Schemes Act (131 of 1998) to provide regulatory supervision of private health financing through medical schemes; and functions as a Schedule 3A Public Entity.

VISION

To be an agile and transformative Regulator in order to promote affordable and accessible healthcare cover towards universal health coverage.

MISSION

The CMS regulates the medical schemes industry in a fair and transparent manner and achieves this by:

- **Protecting the public** and informing them about their rights, obligations and other matters in respect of medical schemes.
- Ensuring that **complaints raised by members** of the public are handled appropriately and speedily.
- Ensuring that all entities conducting the business of medical schemes, and other regulated entities, **comply with the Medical Schemes Act**.
- Ensuring the improved management and **governance** of medical schemes.
- **Advising the Minister of Health** of appropriate regulatory and policy interventions that will assist in attaining national health policy objectives.
- Ensuring collaboration with other **stakeholders** in executing our regulatory mandate.

2. SCOPE OF WORK

2.1. Council for Medical Schemes hereby requests experienced and reputable bidders to submit a quotation for maintenance of environmental monitoring system for a period of nine (09) months as per the following specifications.

2.2. The following requirements need to be met by the successful bidder:

2.2.1. General Requirements:

- Experience in maintaining and supporting environmental monitoring systems similar in scope and size.
- Minimum down-time of all environmental monitoring equipment installed
- Reliable and stability of all environmental monitoring equipment installed.
- Reduced number of call outs.

2.2.2. Technical Requirements:

- A thorough knowledge of the working of the environmental monitoring systems installed on premise.
- A thorough knowledge of the environmental monitoring system layout and configuration.
- Staff properly trained on basic fault interpretation and description.
- Providing proper feedback and explanation of faults and possible future prevention thereof to the client.

2.2.3. Reporting and Monitoring

- Must provide monthly reporting on all maintenance activities to the client.
- To provide monthly reporting on faults to the client.
- To provide monthly reporting on corrective actions to the client.
- Hold 4 quarterly meetings with the client to discuss monthly reports and corrective actions required.

2.2.4. Evaluation Methods:

- The successful bidder should be able to identify reoccurring faults and advise the client on the most cost effective and efficient corrective action to mitigate the reoccurrence.

2.2.5. Legislative Requirements

- Compliance to all safety specifications as set out in the Occupational Health and Safety (OHS) Act.
- Compliance to relevant site access procedures.

2.3. The successful bidder is expected to render the following services to the client:

2.3.1. The successful bidder will be expected to have a dedicated team available. This team must be trained on the site- specific installation, the details of which are provided below. Part of this team must be assigned to perform the Monthly maintenance on the system. A minimum of two technicians should form part of this team and they will be responsible for the emergency callouts and advanced repairs on the system. The successful bidder must provide a dedicated e-mail address as well as an emergency number where all Call/Requests can be logged.

2.3.2. It will be expected of the successful bidder to adhere to the following **maintenance procedures**:

2.3.2.1. Provide a monthly inspection on site (1 day a month). The following activities need to be undertaken at a minimum:

- All sensors to be fully tested. This test to include:
Full battery test where applicable.
- Inspection of gas emission system.
- Test sensors for detection of smoke, humidity and temperature.
- Simulation of fire alarm and auto arming of system.
- Equipment to be cleaned if applicable.

2.3.2.2. Inclusion of two (2) general or ad-hoc call outs limited to a total of 8 hours total time per month.

- On an ad-hoc call out, a technical team should be deployed within 8 working hours to attend to the problem on hand.

2.4. The prospective bidder must be able to provide the client with the following warranties.

- A complete and comprehensive maintenance check must be performed within each month on the whole system.

- All newly installed, replaced, and repaired components as well as workmanship performed must carry a minimum of a one-year warranty from date of supply with the understanding that such warranty will expressly include only items covered by the manufacturer of the products and components.
- Replacement of newly installed equipment free of charge where such equipment still falls under the warranty of the supplier.

2.5. The following will be excluded and not deemed part of services rendered:

- The cost of newly installed, replaced, or repaired components.
- Fair wear & tear and damage occurring due to lightning, power surge, any act of God or malicious / forced activity will be expressly excluded from the bidder's responsibility to provide warranties.

3. EVALUATION CRITERIA

3.1. Evaluation of bids will be conducted in two (2) Phases as follows:

3.4. General Conditions to specific goals

3.4.1. Only a bidder who has completed and signed the declaration (SBD 6.1.) part of the RFQ documentation will be considered for preference points.

3.4.2. CMS may, before a RFQ is adjudicated or at any time, require a bidder to substantiate claims it has made with regard to preference.

3.5. Submission of mandatory documents

3.5.1. Bidders must submit the following documents for verification of specific goals points:

- Attach certified copy/ copies of South African ID of Directors/ Owners/ Shareholders to claim points for **Historically Disadvantaged Individuals (HDI)**
- B-BBEE Certificate and Sworn Affidavit to claim points for **Size of the Company**
- Attach medical certificate/ letter from the accredited Health Professional to claim points for **Ownership for People Disability**
- Attach copy of B-BBEE Certificate/ sworn affidavit, certified ID copy/ copies, CIPC document to claim points for **Black Women Owned Enterprise**
- Fully completed and signed **SBD 6.1.**

3.5.2. Failure on the part of a bidder to submit proof and above-mentioned documentation, complete and sign as required in SBD 6.1. in terms of this bid to claim points for specific goals with the bid, will interpret to mean that the preference points for specific goals are not claimed.

4. INSTRUCTIONS TO BIDDERS

4.1. Terms and Conditions

The Council for Medical Schemes reserves the right, under exceptional circumstances, to extend the closing date. All proposals and all subsequent information received from bidders will not be returned.

The adjudication process does not represent a commitment on the part of Council for Medical Schemes to proceed further with that proposal or of any other bidder.

4.2. Changes to this RFQ document

Council for Medical Schemes reserves the right to make changes on this RFQ Document. All changes will be communicated to those firms that have responded to the RFQ. No reliance shall be placed on other information or comment from any other person.

4.3. Validity Period

The validity period of the RFQ/RFP is **ninety (90)** days. Request for extension of validity period will be communicated to those service providers who responded to the RFQ/ RFP.

4.4. Confidentiality

Any information relating to the submissions, through the process or otherwise shall be treated in strict confidence.

4.5. Other matters

Council for Medical Schemes reserves the right not to enter into any relationship and no correspondence pertaining to submissions will be entered into.

If the Council for Medical Schemes does not accept any proposal, it will declare this RFQ call process closed and may then elect to:

- Proceed on a completely different basis; and
- Not appoint any respondent in the event it deems proposals not appropriate.

The Council for Medical Schemes will not accept any responsibility for costs incurred by bidders in preparing and submitting proposals.

The Council for Medical Schemes reserves the right to engage in a process to validate all claims made in the proposal.

The Council for Medical Schemes reserves the right to cancel the award if it is determined that the supplier/service provider recommended for award, has engaged in corrupt or fraudulent activities in competing for the contract in question. For the purposes of this RFP/RFT, RFQ, "fraudulent practice" means a misrepresentation of facts in order to influence a selection process or the execution of a contract to the detriment of the accounting officer/authority, and includes collusive practices among bidders/contractors (prior to or after submission of proposals) designed to establish prices at artificial, non-competitive levels and to deprive the accounting officer/authority of the benefits of free and open competition.

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

80/20	or	90/10
$Ps = 80 \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$	or	$Ps = 90 \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$

Where

- Ps = Points scored for price of tender under consideration
- Pt = Price of tender under consideration
- Pmin = Price of lowest acceptable tender

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

80/20	or	90/10
$Ps = 80 \left(1 + \frac{Pt - P_{max}}{P_{max}} \right)$	or	$Ps = 90 \left(1 + \frac{Pt - P_{max}}{P_{max}} \right)$

Where

- Ps = Points scored for price of tender under consideration
- Pt = Price of tender under consideration
- Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether

the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
