Introduction to the NRF

The NRF is the government's national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities.

Introduction to the Business Unit responsible for this RFQ

iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites in the Western Cape and Gauteng respectively, these provide facilities for:

- Basic and applied nuclear physics research using particle beams
- Research Radiation Biophysics
- The supply of accelerator-produced radioactive isotopes for nuclear medicine and research

- Evaluation of proposals:

All proposals will be evaluated by Supply Chain Management for administrative compliance, functionality, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to successful bidder.

- Preference points system:

360-degree images capture specifications:

Service providers will need to capture areas in HD using a 360-degree camera/scanner.

Service providers must have 5 years or more experience in capturing images for a virtual tour.

Service providers will need to capture images in high resolution with an output format of (2048 x 1024) 180x360 JPEG format or similar.

Each area that will be part of the tour will need to be covered from multiple angles, where required.

All 360-degree images captured must be supplied to iThemba LABS.

Tour design and website imbedding

Tour will have to display iThemba LABS branding and the theme in the corporate colour pallet.

Service provider will be required to consult with iThemba LABS on design of the tour.

The virtual tour will need to comprise of a “lobby” area through which users must be able to navigate to the different tour areas included in the virtual tour.

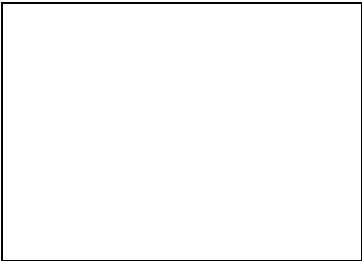
