Specifications

Background

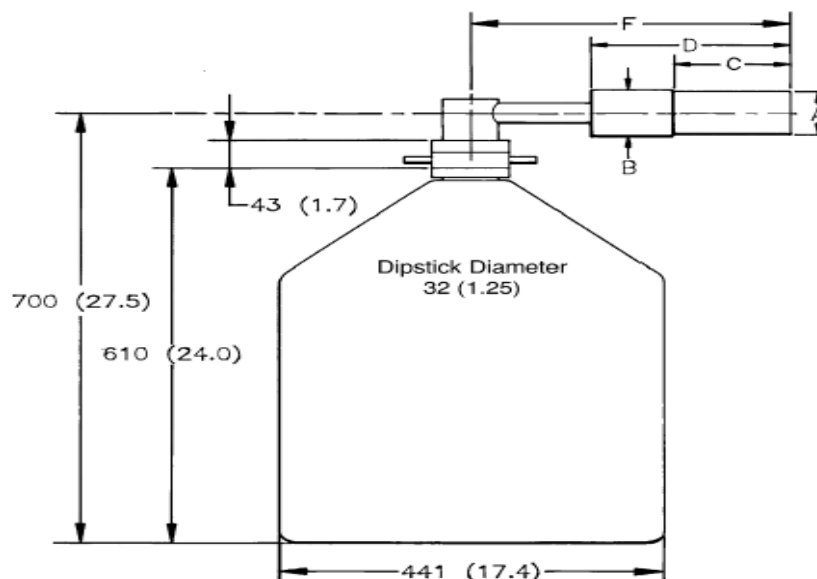
The specifications listed here describe the parts of an integrated High-Resolution Gamma-Ray Spectrometry Analytical System - which is used to examine the radionuclides in the cooling water of proton irradiated targets on the VBTS. The detector is situated in a passive (Pb) shield and the water pipe passes in front of the active part of the detector. This system will be connected to a standalone multi-channel digital spectrometer, NetMCA or Pixi-NET, through the HPGE detector's preamplifier. Detector bias and Low Voltage is currently supplied through standard (NIM) electronics. Here list of the required parts and their specifications:

DETECTOR:

P-type coaxial HPGe with Relative Efficiency 10-15%, and Energy range ~40 keV – 3 MeV. With FWHM resolution (keV) of 122 keV: 0.80 – 1.30 and 1332 keV: 1.75 – 2.30. Peak Shape Gaussian (FWTM/FWHM): 1.90 – 2.00. Must support HIGH count rates (> 10kHz)

CRYOSTAT (COOLING):

A Dewar which supports a minimum of seven days of LN2 cooling at bias, with a vertical dipstick style and the detector at a right angle (horizontal) to the dipstick (see example of the orientation figure below – this is display purposes only) (minimum cryostat volume: 30 L). The Dewar must be size-fit compatible with the detector. (A = 70mm; B = 75mm; C = 134mm; D = 250 mm; F = 396 mm). Alternate cooling systems can be considered with the same specification.



PREAMPLIFIER AND CABLE PACKAGE:

The preamplifier, and all associated cabling, must supply the minimum of (preferably under software control in a user Interface):

- (1) Power connectivity for the preamplifier (+/-12V, +/-6V, or combination thereof, or similar);
- (2) HV Bias (< 4kV) for the Germanium detector;
- (3) Monitoring of the detector element temperature as a reflection of the cooling of the detector;
- (4) Automatic HV shutdown if the temperature of the cooling element exceeds a minimum temperature for safe operation of the biased detector [CRITICAL];
- (5) Signal Output/Data cable to couple to a programmable MCA (NetMCA or PixieNET) typical gain of 200mV/MeV. Dynamic range <2V, single ended or differential output;
- (6) Test Input for Preamplifier testing;

The supplier may suggest variations to the above requirements if they support and make the components or their integration more efficient. Temperature monitoring and HV bias control is strictly required.

The supplier of the listed equipment must illustrate relevant and documented expertise in the gamma-ray spectroscopy. They should also quote at least two contactable references for their work with these detectors. The response to this RFQ must include all costing, delivery time, and documentation. If alternatives or further options are offered, they must be clearly listed with explanations to their advantages to the base specifications listed above.
