RATES TENDER FOR BUILDING, CIVIL AND FENCING FOR A THREE YEAR PERIOD

Tenders are hereby invited for the appointment of a panel for the abovementioned services.

Tender documents, in English, are obtainable from Monday, 28 June 2021, at the reception of Cederberg Municipality, 2A Voortrekker Street, Clanwilliam, between 08:00 and 16:00 (Monday-Thursday) and Friday 08:00 -14:00 upon payment of a tender participation fee.

Tenderers must be registered with the CIDB in a relevant class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with regulation 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers should have a grading designation of 1GB, 1CE, 1EB, 1ME, 1SQ - 4GB, 4CE, 4EB, 4ME, 4SQ.

Payment of a non-refundable tender deposit of **R841.00** (VAT inclusive) is applicable. The amount must be deposited into Cederberg Municipality's account at Standard Bank, Branch Code: 05-0106, Account No: 082 163 324. The reference number when doing payment is: CED 27/2020-2021 – Company Name. Proof of payment is necessary when collecting tender documents.

Tenders, in sealed envelopes, clearly endorsed with: **"TENDER NO. CED 27/2020-2021: RATES TENDER FOR BUILDING; CIVIL AND FENCING WORKS"** must be deposited in the Tender Box at the offices of the Cederberg Municipality, 2A Voortrekker Street, Clanwilliam. Bids may only be submitted on the bid documentation issued by Cederberg Municipality.

Only goods, works and services with a stipulated minimum threshold as applicable for local production and content will be considered. The stipulated minimum threshold(s) for local production and content (refer to Annex A of SATS 1286:2011) for this bid is/are as follows:

A compulsory site clarification meeting with representatives of the Employer will take place at the Cederberg Municipality Sports field, Park Street, Clanwilliam on **Monday, 12 July 2021** starting at **11:00**. Prospective tenderers who arrived later than 11:15 will not be allowed into the clarification meeting.

The closing date and time of the tender is on **26 July 2021** at **12:00** and tenders will be opened in public immediately thereafter in the Supply Chain Management Committee Room, Clanwilliam Administration.

Tenders must be valid for a period of 120 days after the closing date. The tender will be evaluated according to the 80/20 Preference Points System, as prescribed by the Preferential Procurement Regulations, 2017.

The Cederberg Municipality does not bind itself to accept the lowest or any tender and reserves the right to accept any or none of the tenders submitted, as it may deem expedient. Tenders are subject to the Supply Chain Management Policy of the Cederberg Municipality.
