Service providers are hereby invited for the establishment of a panel of service providers for the provision of maintenance of electrical substations; electrical panels; electrical motors and electrical transformers in arear of jurisdiction of uThukela Water (Pty) Ltd for a period of three (3) years.

All qualifying service providers would be appointed as panellist service providers on the basis of functionality and preferential scoring system would only be effected when sourcing quotations, and the award will be made to highest point scoring service provider, subject to objective criteria. Bids will be adjudicated in terms Preferential Procurement Policy Framework Act 5 of 2000; Preferential Procurement Regulations of 2022; uThukela Water SCM Policy and other applicable legal framework and will be based on 80/20-point system.

Pre-qualification Evaluation:

Only service providers that comply with all administrative requirements (acceptable tenders) will be considered during the prequalification phase and the allocation of points will be based on functionality.

Special Condition: Preference will be given to service providers who have established business within uThukela Water area of jurisdiction which covers Newcastle Local Municipality, uMzinyathi District Municipality and Amajuba District Municipality.

Minimum functional score: Service providers submitting acceptable tenders and scoring at least **70%** on functionality will qualify to be on the panel, and the utilization will be based on as and when required basis by seeking quotes.

Completed bid documents complying with the conditions of bid must be sealed and endorsed "BID No: **OPS2023-BID/009 – "Panel of Service Providers for Electrical Work"** bearing the name and address of the bidder at the back of the envelope to be deposited in the official tender box at uThukela Water (Pty) Ltd, 79 Harding street , Reception, Newcastle by no later than 12:00 on Thursday, 20th April 2023 where bids will be opened in public. Late quotations or tenders received by way of facsimile or e-mail will under no circumstances be considered.
