PURPOSE OF THE ASSIGNMENT

To Development an Abattoir Feasibility for Vhembe District Municipality

Introduction

Vhembe District is a rural Municipality found in the northern part of Limpopo Province. One of the District economic drivers is agriculture. The Municipality through its Agriculture Development section intends to establish an Abattoir facility. The intended Abattoir should have a capacity to slaughter cattle, sheep, goats and pigs. Furthermore the envisaged Abattoir should also able to be financially self-sustainable and complaint to Abattoir regulations. However before an Abattoir can be established, Vhembe District Municipality felt it prudent to first commission a feasibility study which will inform the Abattoir viability, its economic potential and also propose feasible operations models to be considered.

SCOPE OF WORK/DETAILED SPECIFICATIONS/TERMS OF REFERENCE

1. Status Quo Assessment

Conduct an assessment of an ideal performance of an abattoir looking at the following:

- Supply side of an Abattoir
- Demand side of an Abattoir
- The carrying Capacity
- Quantify the economic value and impact of the Abattoir
- Cash flow assessment
- Human resource capacity
- The required infrastructure to meet the demand
- The required equipment and general infrastructure value of the Abattoir
- Compliance with the required standard as indicated in the Meat Safety Act.

2. Policy Assessment

- Review of the implications and intentions of different relevant policies in place to ensure compliance and alignment when implementing the recommendations of the feasibility study.
- Some of the plans that the study should align itself with are following:
 - Census of Small-Scale Agriculture in Vhembe District 2023
 - Census of Commercial Agriculture (statistics South Africa 2017)
 - Vhembe Rural Development Plan 2019
 - Integrated Development Plan and Agricultural strategy of Vhembe District Municipality

3. Opportunity Assessment

- Conduct an assessment and analysis of the economic development potential of the abattoir
- Expansion prospects
- Prospects of introducing other services (hide treatment facility, processing, packaging etc.) to improve the value chain.

4. Market Analysis

- The market analysis should focus on the abattoir to maximize its competitiveness in the market.

5. Operational Models

- The study should propose feasible operational models for VDM to consider, a model which could position the Vhembe Abattoir firmly within the industry, make profit and be financially self-sustainable.
- The study should propose models with implementation plans. The report should give factual recommendations for the possible models and weigh the models against each other.

6. Implementation plan

- The study should suggest an implementation plan that could incorporate the following amongst others:
- Estimated costs for the proposed model
- Propose the institutional arrangements for the recommended operational model.

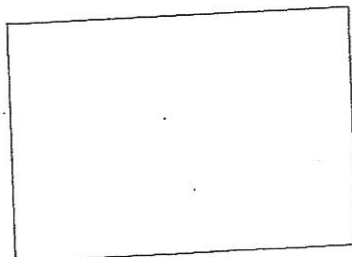

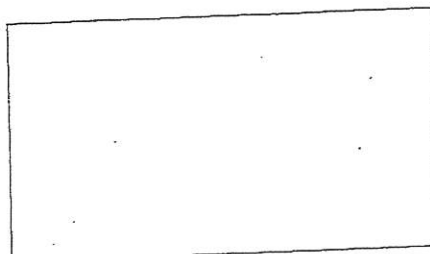

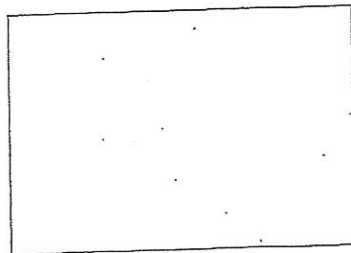

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
