❖ **PURPOSE**

The Nelson Mandela Museum hereby invites suitably qualified and experienced service providers to submit quotations for the supply, delivery and installation of interpretive signage, murals, and photographs at Nelson Mandela Museum (Qunu) in Pretoria.

❖ **SCOPE OF SERVICE**

- The appointed service provider must have the facilities and capacity to handle, transport and store the artwork with care, avoiding damages in transit or otherwise. The service provider will be required to uplift the artwork pieces, frame same and return to the premises of the Museum.
- The service provider must have experience as an art work framer and how to frame and how to frame in order to conserve the various types of art work.
- The service provider must have in their employ professional framer/s who have experience in framing art pieces and who are knowledgeable on how to frame in order to conserve the various types of art work.
- The Museum will provide the service provider with the details of the art work pieces that require framing from time to time and the service provider will provide a cost effective quote on each occasion during the currency of the contract. Framing occurs once or twice in a year and it will be in line with the annual acquisitions of artworks.
- The artworks are insured by the Museum in transit, however the service provider is expected to comply with OHS, physical security for artworks and professional handling.
