TERMS OF REFERENCE

6. OUTLINE

These Terms of Reference outline the Scope of Works for which the service provider is responsible. It defines key accountabilities and what the service provider is responsible for supplying & delivering. The terms of reference give details of the type of the change room container that the municipality wants to purchase and any other information that will be of useful information to the bidders / suppliers.

7. BACKGROUND

Community Services department is comprised largely by the waste removal workers who mainly remove, pack, transport, dispose waste, cut grass, remove & de-stump alien plants using hands and power tools. The kind of waste removed is largely categorised as contaminated as most of the time comes out of storage by various households and businesses for some time in their premises. This then means the nature of their work is dusty, stinky and dirty thus workers will need to refresh/shower before leaving the workplace. This is more eminent currently due to the Covid 19 pandemic which one of the major preventive measures of the virus is to practice excellent hygiene standards.

The municipality therefore aims to purchase a customised container to assist in the purpose mentioned supra:

This bid will be subjected to functionality assessment. The bidder must score a minimum of 70% to proceed to the second stage. The municipality will consider the life span of the container provided by the service provider in terms of quality and how good the type of equipment that is provided. It is expected that all the equipment that will be provided as per the specification provided. It is expected that the equipment will be delivered to the Municipality 30 days after receiving and accepting the appointment letter, failing to do this

will be deemed to be in breach of Contract. The equipment must carry a minimum of 1-year warranty from the manufacturer and this must be provided to the municipality before the municipality issues a completion certificate.

9. CONDITIONS OF APPOINTMENT

Compliance with and performance in terms of the Terms of Reference is a specific condition of the appointment of the Service Provider. Municipality will provide all relevant information available for successfully completing the project. The quoted amount must cover for all the costs that will ensure full completion of the project. The appointed service provider must after signing the acceptance letter communicate with the Manager Environmental Services. The equipment must be bought in the name of the municipality so that the warranty can be transferred over to the municipality.

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).
