1. Background

The SABS is a statutory body established in term of Standards Act, 1945 (Act No. 24 of 1945) and continues to operate in terms of the Standards Act, 2008 (Act No. 8 of 2008) as the national standardization institution in South Africa, mandated to:

- develop, promote and maintain South African National Standards.
- promote quality in connection with commodities; and
- render conformity assessment services and matters connected therewith.

2. Request for Quotation (RFQ)

This RFQ serves as an invitation to submit a quotation for the supply and delivery of water bath equipment, subject to the SABS Standard Terms and Conditions, of which a copy is available on [www.sabs.co.za](https://www.sabs.co.za/Procurement/proc_toc.asp), accessible through the link: https://www.sabs.co.za/Procurement/proc_toc.asp

The Bidder is requested to supply its quotation, in writing, by the specified date. Should the Bidder require any clarification, the clarification should be submitted by e-mail to the Procurement Specialist identified in this document.

By submitting a quotation in response to this RFQ or participating in this RFQ process, the Bidder accepts that it is subject to and bound by all the terms and conditions contained in this RFQ document.

3. Confidentiality

This document may not be used for any purpose by the Bidder other than for developing their response to it, and all reasonable efforts must be taken by the Bidder to ensure confidentiality of any information provided. This document and any other information of a confidential nature provided to the Bidder during RFQ process are and will be covered by the non-disclosure agreement to be signed between the SABS and the Bidder.

4. No Contract

Bidders shall note that this RFQ does not commit the SABS to any course of action resulting from the receipt of quotations and the SABS may, at its discretion reject any submission which does not conform to instructions and specifications which are contained herein or select a Bidder based upon its own unique set of criteria. SABS also reserves the right not to select a bidder.

Nothing in this document shall be construed as a contract between the SABS and the Bidder, and no communication, whether verbal or written, by the SABS personnel or agents during this process shall create such a contract in respect of the requirements specified in this RFQ.

5. No Obligation to Proceed

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder because of discontinuation of the RFQ process.

6. Validity of Proposals

The Bidder's quotation shall remain valid for a period of one hundred and twenty (120) days from the closing date. The SABS may at any time prior to the expiry of the bid validity period, extend the above validity period by sixty (60) days by written notice to the Bidders. In that event, the SABS will not require any consent from the Bidders, and bidders will not be required or permitted to amend any of their quotations.

SABS retains the right, but is under no obligation, to request Bidders to extend the validity periods of their quotations, prior to expiry thereof, if it has already invoked the extension referred to above and it is in the SABS' interest to further extend the bid validity period. Such a request shall be in writing. The Bidder is not obliged to extend the validity period. Also, bidders will not be required or permitted to amend any of their quotations.

7. Scope of work/ Specification

7.1 Purpose of this document

Supply, install, and commission water bath equipment for conditioning Two Wheeled Refuse Bins. The equipment shall be used to condition the Two Wheeled Mobile Refuse Bins in accordance with SANS1494:2023 clause 8.5 and 8.6 at various temperatures for specific hours without any temperature or condition deviations.

7.2 Applicable and reference documents

1. SANS 1494:2023 Two Wheeled Mobile Refuse Bins,
2. clause 8.5 of the above standard - Test for resistance to exposure to elevated temperature. 3. Clause 8.6 Test for resistance to environmental stress cracking

7.3 Requirements

Supply of a complete Water Bath Equipment capable for conditioning the Two Wheeled Mobile Refuse Bins in accordance with SANS1494: 2023, clauses 8.5 and 8.6, with the below minimum proposed requirements:

- To be filled with water/solution without leakage
- Temperature to range between 0 to 100°C,
- Able to maintain the temperature at +/-2°C tolerances, e.g. 70 +/-2°C for specific hours.
- Ensure that the equipment of cabinet can accommodate 2 wheeled bin samples and ensure that air can freely circulate around the samples during conditioning.

- Ensure that the material used to manufacture the equipment/cabinet are corrosion resistant e.g. galvanized or painted with corrosion resistant paint.

The service provider is responsible for packaging, shipping, offloading and installation including all related resources. Any modifications required at the SABS test facility for safe and effective operation of the system must be identified in the quotation and accommodated by the service provider.

Where integration with existing SABS equipment, computers, test infrastructure or data systems is required, the supplier shall include all necessary hardware, software, interfaces and engineering services.

The service provider shall indicate the warranty period, maintenance schedules, recommended calibration intervals, software support arrangements and supply all supporting documents including manuals.

Drawings, system architecture, technical datasheets and specifications shall be submitted together with the quotation.

7.4 Installation

The service provider shall install the equipment at SABS, Mechanical Testing, Packaging Laboratory and integrate. Installation shall include all mechanical, electrical, electronic, software and communication requirements necessary for a fully functional system.

The supplier shall provide an installation method statement and identify any site requirements, including electrical supply, mounting points, test area requirements, communication requirements and any required modifications, before installation.

All installation work shall be completed by suitably competent personnel and shall leave the test facility safe, clean and ready for operation.

7.5 COMMISSIONING

The supplier is expected to be available to ensure that the equipment functions according to the requirements of this specification.

Commissioning shall include functional checks e.g. verifications of the conditions as stated in the Requirements.

The supplier shall provide commissioning results and a signed commissioning record for acceptance by SABS.

7.6 TRAINING

The service provider is responsible for training of 3 personnel in the laboratory.
The service provider shall ensure that the trained personnel are competent in operating the equipment.

7.7 DOCUMENTATION

All necessary documentation shall be supplied in English, in electronic format and, where requested by SABS, in hard copy.

- User/operator manual.
- Technical and service manual.
- Installation and commissioning documentation.
- Electrical/wiring and connection diagrams, where applicable.
- Calibration certificates (SANAS accredited) and calibration procedures.
- Maintenance schedule.
- Troubleshooting guide.
- Recommended spare-parts list.
- Factory/site acceptance test documentation, where applicable.
- Training material.
- Warranty documentation.

Note: SABS will evaluate each document. SABS can decide at its own discretion if any document is not sufficient. In such a case the supplier will be responsible to update the document to SABS satisfaction.

7.8 SERVICES TO BE SUPPLIED BY SABS

The supplier is responsible for notifying SABS of any service that might be required for the operation of the equipment. This notification must be submitted together with the original quotation.

7.9 CONDITIONS

The supplier is required to ensure that all requirements specified in the technical specification are met and supported by scientific evidence. Any deviations, limitations, assumptions, or additional requirements shall be clearly defined.

7.10 MANDATORY REQUIREMENT

- **Meet technical specifications specified** – Bidders must attach a detailed brochure of technical data sheet of the proposed water bath.
- **Confirmation that the service provider will be able to provide the complete system** – Bidders to provide a declaration.

- **Confirmation that the service provider will be able to provide installation, commissioning and training** – Bidders to provide a declaration.
- **Confirmation that the service provider will be able to provide online and physical system support** – Bidders to provide a declaration.
- **Demonstrated capability to support testing to SANS1494:2023, clauses 8.5 and 8.6 requirements** - Bidders to provide proposal, or presentation and/or pictures to visualise the equipment and ensure that the supplier will provide the specified equipment accurately.
- **The equipment shall ease of operation and shall have a temperature display screen showing the actual temperature reading** - Bidder to submit a digital probe or data sheet.
- **Accuracy, traceability and suitability of the measurement system** – Bidder to submit a data logger or data sheet capable of displaying and recording the readings.
- **Local technical support and availability of spares with assurance that the supplier will be readily available to provide assistance when required and that spare parts will be available when needed** – Bidder to submit a declaration.

Only Bidders who submitted quotations as per the requirement and mandatory requirements will be evaluated further on 80/20 preference points system of 2022. (Pricing and Specific Goal).

10 Quotation

The quotation should include but not limited to the following:

- Total cost all-inclusive of VAT
- Cost breakdown
- Installation and Commissioning
- Training
- Transportation cost (If applicable)
- Disbursement (If applicable)

- Fixed price, where foreign currencies are involved, bidders should make provision for forward cover.

11 Contact information

The SABS will not make an upfront or advance payment to a successful Bidder. Payment will only be made in accordance with the delivery of service or goods that will be agreed upon by the SABS and the successful Bidder.

13 Responsibility for costs

Under no circumstances shall the SABS be responsible for any of the Bidder's costs associated with the preparation and/or submission of its quotation, including any costs incurred by the Bidder prior to the signature, by both parties, of an agreement resulting from a successful bid.

14 Bidder's contractual terms

The SABS will not be bound by any legal or contractual terms as may be included in the Bidder's quotation, in response to this RFQ.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

The Supplier shall not make copies of the Confidential Information or otherwise disseminate any of the Confidential Information (except as may be required to fulfil specific obligations towards South African Bureau of Standards) without South African Bureau of Standards express prior written consent.
3. This agreement applies to information whether such information is marked as or appears to be confidential and whether or not such information is of commercial use to South African Bureau of Standards or any other party.
4. This agreement shall not apply to information which: -
 - (a) the Supplier can show had been lawfully received by it prior to disclosure under this agreement.
 - (b) is in the public domain or becomes so otherwise than through breach of this agreement.
 - (c) was disclosed to the Supplier by a third party who was under no obligation of confidence in respect thereof.
5. The South African Bureau of Standards retains ownership of Intellectual property rights on all material and processes relating to the service provided for and on its behalf by the supplier.
6. The Supplier shall observe its obligations under this agreement until expiry of a period of 12 months from the date of signature.
