1. PURPOSE

The purpose of this RFQ is to appoint a suitably qualified service provider to deliver customised accredited training in Field Guiding - Nature Site Guide L2 & L4 for 15 learners in the Mpumalanga/Skukuza. The training will be conducted in two phases over a six-month period at the service provider's training venue. The appointed service provider must also provide suitable accommodation for the learners for the duration of the training periods.

2. BACKGROUND

South African National The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA), in collaboration with South African National Parks (SANParks), is implementing a high-impact skills development project aimed at addressing priority sector skills needs and supporting sustainable employment within the tourism and conservation value chain.

This collaboration forms part of CATHSSETA's strategic initiative to support high-impact projects that contribute to sector transformation, capacity building, and alignment with national skills development priorities, including the National Skills Development Plan (NSDP).

SANParks, as a key implementing partner, brings sector-specific expertise and operational capacity to support the effective delivery of the project. The partnership seeks to ensure value for money, compliance with applicable legislative and regulatory frameworks, and the achievement of intended project outcomes.

In support of the implementation of this initiative, a Request for Quotation (RFQ) is hereby issued to invite accredited and experienced service providers to submit quotations for the provision of the required services, as detailed in this document.

SANParks requires a service provider to deliver a customised field guiding course to 15 learners in the Mpumalanga/Skukuza area. The service provider should be able to cover the following unit standards that will enable learners to attain a skills programmes certificate(s)

The appointed service provider will undertake the following:

5.1 Deliverables

- Provide all required training material for the duration of the training.
- Deliver the training in line with the required hours stipulated in the skills programme outline.
- Register learners with Cathsseta before the unit standard/skills programme before the 30 June 2026..
- Submit signed attendance registers and progress reports to the client monthly by an agreed date.
- Represent training provider in the relevant steering committee to provide training report.
- Ensure learners are competent within a year of commencing with the programme. Where learners are Not Yet Competency, a remedial plan needs to be in place and followed through.
- Issue statements of results and competency certificates for learners.
- Provide a close out/evaluation report at the end of the training.
- Partner with an accredited shooting range where necessary.
- Accommodate and deliver training in an OHS compliant venue.
- Register 9 extra learners on CIMS.

6. LOCATION OF THE TRAINING

Training will be conducted at the venue arranged by the service provider.

7. OTHER IMPORTANT INFORMATION TO NOTE

Accommodation and training venue will be inspected prior to learning to:

- Confirm capacity to accommodate the number of learner in the programme. The rooms cannot be shared by more than 4 learners.
- OHS compliance certificate is displayed at the premises.
- Confirm at least 3 staff members to either cook & clean the learner shared space.

8. PERIOD AND DURATION

- The training duration shall comply with the prescribed regulatory requirements for the unit standard/skills programme, over a maximum period of six (6) months.

9.1. Phase 1: Mandatory Evaluation Criteria

All mandatory documentation must be submitted by the bidder together with the RFQ Terms of Reference document at the closing date and time of the RFQ. Failure to comply with the mandatory requirements will lead to the bidder being disqualified from further evaluation.

- **Training Provider Accreditation:** Proof of accreditation with CATHSSETA and specifically have the unit standards on their scope Accreditation for Nature Site Guide L4 and VPDA. As per the scope of work.

9.2. Phase 2: Functionality Evaluation Criteria

- In this phase bidders will be assessed on their capability, capacity and demonstrated experience to deliver the required services in accordance with the criteria set out below.
- **Qualification Threshold:** Bidders must achieve a **minimum score of 75 points** out of 100 points on functionality criteria to qualify for consideration in the next phase. Bidders who fail to meet the minimum score of 70 points will be disqualified from further evaluation

The contracted supplier shall assist SANParks in obtaining statutory protection for the contract intellectual property at the expense of SANParks wherever SANParks may choose to obtain such protection. The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to SANParks, or as SANParks may direct, and to support SANParks, or its nominee, in the prosecution and enforcement thereof in any country in the world.

The contracted supplier hereby irrevocably appoints SANParks to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that SANParks, in its absolute discretion, requires in order to give effect to the terms of this clause.

The rights and obligations set out in this clause shall survive termination of this contract indefinitely.

Confidentiality

The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not:

- (a) Disclose the confidential information, directly or indirectly, to any person or entity, without SANParks' prior written consent.
- (b) Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or
- (c) Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.

The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to

- (a) Disclose the confidential information to any third party, or
- (b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- (a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks;
- (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or
- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and

(c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.
