1. INTRODUCTION

The Atlantis Special Economic Zone (ASEZ) was officially designated in October 2018. The success of the ASEZ rests on strong collaboration across the public and private sector spectrum. The promulgation of the ASEZ was enabled through collaboration between the Department of Trade and Industry and Competition (DTIC) and Western Cape Government (WCG)'s Department of Economic Development and Tourism (DEDAT), Wesgro and the City of Cape Town (CoCT). Initially inspired by the City of Cape Town's Green Technology Manufacturing Hub, these parties are working together to facilitate the development of the SEZ in Atlantis.

The ASEZ is a keystone initiative that sits within the country's broader green economy industrial development strategy. It thus both supports and draws on these initiatives. Ultimately, Atlantis needs to operate as a viable industrial hub within a thriving green economy and contributing to green technology industrialization and job creation in South Africa. It is an important development intervention tool to unlock green industrial development, manufacturing, employment, technology development, enterprise development and skills development, amongst other opportunities expressed in the green sector strategies, policies and plans of government.

2. SPECIFICATION

BACKGROUND

Independent community facilitators have played an important role in a community led approach the ASEZ Company has taken to date. The Community Integration Programme seeks to continue building on this as we seek to integrate a culturally diverse community and achieve the ASEZ's strategic objectives of socio-economic impact in the area.

The process, thus far, has yielded positive results and has led to the establishment of the Atlantis Special Economic Zone Community Stakeholder Network (ASEZ-CSN), a multi-sectoral community forum, endorsed as the conduit between the community and the ASEZ Company.

The ASEZ-CSN's role, together with other community stakeholders, supports the overall engagement process the ASEZ seeks to pursue for maximum support and integration of its objectives and to ensure that the Atlantis community receives all relevant communication the ASEZ Company shares.

OBJECTIVE

Community Facilitation is the practice of providing leadership without taking over the reins, but instead drive alignment to give the community a sense of owning the process and the outcomes. As a service provider for community facilitation your role is to support and equip the Atlantis community with practical skills regarding leadership development and governance. The objectives of community engagement facilitation are twofold; practical capacity building support that will facilitate a transition of self-directed leadership, ownership, accountability and a collaborative approach to community empowerment initiatives. Secondly, the community engagement services are aimed at joint initiatives with the ASEZ Integrated Ecosystem team to address the challenges identified.

A community engagement facilitator provides the methods and means that enable groups and individuals to craft suggested solutions to complex issues facing their community without necessarily being a subject matter expert. Facilitators need to balance time, conflicting needs, the complexity of the issues and the process maturity of the community and help them find the best possible actions to address the issues. Facilitators must use context specific and suitable engagement methods, to assist the community in contributing meaningfully to decision making processes and achieving sustainable commitment and buy-in.

The role of the community facilitator will also align with the ASEZ Integrated Ecosystem work plan and project deliverables.

SCOPE OF WORK:

The services of the community facilitator proposal should provide a full project plan with milestones and include:

Deliverables

1. **Inception report:** The report shall cover an overall project plan (inclusive of a project schedule) with intermediate and final outputs, proposed methodology (additional detail below) and identified timeframes/milestones.
2. **Strategic Support:** Provide support to the ASEZ Company and the ASEZ Integrated Ecosystem team on matters related to the Atlantis Community for the duration of the contract.
3. **Monthly and quarterly project partner meetings:** Facilitate meetings with external partners, CSN and Greater Atlantis Community.
4. **Facilitation of meetings and engagement sessions:** Facilitate meetings with external partners, Community Stakeholder Network (CSN) and Greater Atlantis Community. Assist with the roll out of these sessions to be held with Atlantis beneficiaries and community members and compile a standard operating procedure (SOP) for the ASEZ Co. Facilitate dialogue sessions with concerned community members when issues are raised directly or indirectly related to the ASEZ.
5. **Workshop Facilitation :** Facilitate workshops and using relevant methodologies to provide inclusive and participatory interactive sessions with the community.
6. **Sectoral and Networking Sessions:** Support the Atlantis Community Stakeholder Network (CSN) as they roll out these monthly deliverables and compile a standard operating procedure (SOP) for the ASEZ Co.
7. **Community Engagement Session:**
 - Facilitate meetings preparation with key community stakeholders, CSN and ASEZ IES team.
 - Co-creation of distribution & presentation materials for public events produced by the ASEZ IES team.
 - Facilitate Dry Run and clarification of all issues with ASEZ IES team and CSN members before events.
 - Facilitate quarterly Public Information Sharing Sessions and Public Community Engagement Sessions.
8. **Administrative duties:**
 - Finalise the agenda and formalities of each event in partnership with the ASEZ IES team.
 - Follow-up and provide written feedback reports after meetings.
 - Provide SOP manuals to the ASEZ IES team for the various engagements.

Methodology

The service provider must supply a detailed methodology with this proposal. This must include:

Ad hoc requirements

Offer ad hoc leadership development and capacity building to ASEZ-CSN as they look to becoming operational and functional as a voluntary organization and establishing the organization as a recognized community structure.

REQUIRED SKILLS

The submission of the service provider must demonstrate the following characteristics as an indication of its capacity and readiness to implement the assignment:

1. Preference will be given to an Atlantis based service provider, or a service provider with a proven track-record of successful delivery in Atlantis.
2. At least 5 years' experience in facilitating with community engagements session, community dialogues session and community leadership development and capacitation.
3. Experience with working with historical disadvantage people is a key requirement.
4. Experience in undertaking situational analysis to determine risk attached to the work involved.
5. Experience in community empowerment, facilitation, and capacity building within vulnerable communities.
6. Proven ability in effective written and oral communication.
7. Institutional capacity to successfully carry out an assignment of this nature.
