SCOPE: APPOINTMENT OF AN WASTE MANAGEMENT/ENVIRONMENTAL SPECIALIST TO UNDERTAKE WASTE CLASSIFICATION OF SIX WASTEWATER TREATMENT WORKS

Johannesburg Water (JW) is an entity of the City of Johannesburg (CoJ) responsible for the provision of water and sanitation. Johannesburg Water has six wastewater treatment works that are found at Johannesburg North and South. The wastewater treatment works generate wastewater that is treated in terms of the general and existing water use licence wastewater quality standard.

The National Environmental Management: Waste Act (Act 59 of 2008) (NEM:WA) and the Waste Classification and Management Regulations (R635) require that all waste generated is classified in accordance with SANS 10234 within 180 days of generation.

The scope of a project:

- Waste classification of waste that is generated at the Treatment Wastewater Works.
- Compilation of waste classification assessment report.
- Preparation of a safety data sheet according to the requirements of SANS 10234 for the waste material as well as for the product the waste originates from.
- In terms of regulation 3(5) - A competent person must recommend the pollution control measures suitable for a specific residue stockpile or residue deposit on the basis of a risk analysis as contemplated in Regulations 4 and 5 of the Regulations.
- Determination of waste types through comparison of the Total Concentration (TC) and Leachable concentration (LC) concentrations with threshold limits presented as per and the elements and chemical substances in the waste as per the values specified in section 6 of the Standard.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
