1. PURPOSE OF THE REQUEST FOR QUOTATION

The purpose of this Request for Quotation (RFQ) is to obtain information from qualified service providers regarding available solutions, methodologies, and capabilities for automating journal processing within Johannesburg Water's SAP environment.

This RFQ seeks to understand current market offerings, best practices, implementation approaches, estimated timelines, indicative costs, and vendor experience in delivering similar automation projects.

2. BACKGROUND

Johannesburg Water seeks to appoint a qualified service provider to design, implement, and support an automated journal processing solution within its SAP environment.

Johannesburg Water currently processes manual journal entries within SAP FI. The objective is to reduce manual intervention, improve controls, enhance efficiency, and strengthen audit compliance through automation.

3. SCOPE OF WORK AND SPECIFICATIONS REQUIREMENT

3.1 Process Assessment and Solution Design

- Assess existing journal processes, workflows, and approval hierarchies.
- Identify high-volume and recurring journals suitable for automation.
- Analyse control gaps and inefficiencies and provide a gap analysis with an automation roadmap.
- Design an automated journal solution integrated with SAP FI, including workflow-based approvals, recurring journals, template-based preparation, rule-based validations, and automated postings.

3.2 SAP Configuration, Development and Automation

- Configure SAP system components, including document types, posting keys, general ledger (GL) accounts, validation and substitution rules, and number ranges, to support controlled and standardized financial processing.
- Implement dropdown selection fields for GL account and cost centre. Where an income or expenditure account is selected, the system must prevent the parking of a journal if the required cost centre information is not completed, enforced through appropriate validation controls.
- Implement SAP workflow approvals, recurring entry programs, automated reversal functionality, and document attachment capabilities to strengthen governance and auditability.
- Enable automation features, including mass journal uploads, automated accrual calculations,

3.3 Reporting, Controls and Compliance

- Provide dashboards and reports for journal status tracking, exception monitoring, audit trails, user activity logs, and month-end performance metrics.
- Ensure compliance with GRAP, segregation of duties enforcement, period control, posting restrictions, and logging of overrides.

3.4 Testing, Training and Implementation Support

- Conduct unit testing, system integration testing, and support user acceptance testing.
- Provide end-user and administrator training, technical and process documentation, and knowledge transfer sessions.
- Support go-live activities, provide hypercare support, resolve post-implementation issues, and assist with system performance optimisation.

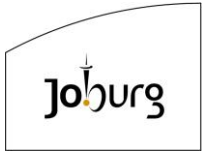
