## **1. PURPOSE**

The purpose of this RFQ is to appoint a service provider to conduct a mini-work-study for specific roles within SANParks to inform grading and job titling decisions.

## **BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

SANParks is undertaking a targeted mini-Work-study exercise to ensure role clarity, internal equity and compliance with approved job architecture and governance framework.

The work-study is intended to provide objective, defensible evidence to inform job grading and job titling decisions using the Paterson Job Evaluation framework.

An initial tranche of three (3) job categories/family, affecting approximately 99 employees, has been identified for review. The work will be focused, time-bound, and evidence-driven.

## 2. SCOPE OF WORK

South African National Parks (SANParks) hereby invites suitably qualified and experienced service providers to submit quotations to conduct a mini-Work-study. This is a limited focussed intervention for specified positions within the organisation.

### 1. Purpose

The purpose of this assignment is to conduct a rapid, structured, and evidence-based mini-Work-Study that confirms actual work content, validates accountability and decision-making authority, supports standardised job titling, and produces panel-ready evidence for Paterson grading deliberations.

### 2. Objectives:

- Analyse actual work performed through structured evidence gathering.
- Confirm role purpose, outputs, autonomy, and spans of control.
- Recommend standardised job titles aligned with SANParks architecture.
- Produce Paterson-aligned role profiles for JE panels.
- Identify duplication, inefficiencies, and streamlining opportunities.

### 3. Scope of Work

3.1 **Document Review:** analyse existing job descriptions, process maps, KPIs, org charts and previous JE outcomes.

3.2 **Stakeholder consultation:** structured interviews with incumbents, line managers, HCM, targeted focus groups where multiple incumbents exist. A list of stakeholders to be provided.

3.3 **Work sampling and task analysis:** valid task frequency, time distribution (Time-Spent analysis).

3.4 **RACI / decision-rights analysis:** clarify boundaries, interfaces and governance.

3.5 **Benchmarking:** cross reference titles and role levels against comparable organisations.

3.6 **Synthesis:** prepare concise role profiles and JE evidence matrices; propose standard titles, flag overlaps, gaps and duplications.

- **Duration of the project**

The anticipated duration is **8 weeks** from the signing of the contract/signing of the order. Bidders must submit a detailed project schedule with dependencies, resource allocation, and assumptions.

#### **4. Proposed Methodology & Approach**

- **Inception:** confirm roles list, data needs, sampling approach, and reporting templates; refine project plan and risk register.
- **Data collection:** interviews (virtual/onsite), limited observation, document analysis; ethics and POPIA-compliant handling of personal data.
- **Analysis:** task grouping, complexity assessment, Paterson calibration lens (KPA), and interface mapping.
- **Validation:** playback sessions with line managers and HCM/OD to test findings and resolve discrepancies.
- **Finalisation:** deliver evidence packs per role and consolidated insights for management and JE Committees.

#### **5. In-scope Roles**

The initial list of roles will be provided at inception; Bidders must price per scope of work. SANParks anticipates an initial tranche of **3 roles, affecting 99 employees** across the organisation.

#### **6. Deliverable and Outputs**

- Inception report and detailed project plan with milestones and interview schedule.
- **Per-role evidence pack including:** (a) validated role purpose and key outputs; (b) task inventory with frequency/criticality; (c) decision-rights/RACI snapshot; (d) spans of control and key interfaces; (e) recommended standard job title with rationale; (f) Paterson calibration summary (KPA indicators) for JE panels.
- Consolidated management report with themes, duplication/overlap findings, and quick-win recommendations.

- Clean, panel-ready role profiles in SANParks' approved template (Word) and a slide pack summarizing findings (PowerPoint).
- Source data and working papers (interview guides, anonymized notes) handed over to HCM/OD.

### Phase 1: Mandatory evaluation criteria

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:
