NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the

RSA.

-
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, ~~the purchaser may procure, upon such terms and in such manner as it~~ deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any

person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which

25. Force Majeure

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.

27.5 Notwithstanding any reference to mediation and/or court proceedings herein,

(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and

(b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;

(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

1 BACKGROUND

Limpopo Department of Education, through the Education Management Information Systems (EMIS) Unit collects, processes, reports and disseminates education data and information to support planning, decision-making and the effective monitoring and evaluation of the performance of the education system. Data Quality Audit is central to ensure that the data collected by the Department through the execution of the EMIS function is considered reliable and accurate.

2 INTRODUCTION

Limpopo Department of Education hereby invites potential bidders to bid for a tender for the appointment of a service provider to conduct an audit on the quality of data collected by the Department in 247 Entities (Institutions) within a period of four (4) Months.

3 SCOPE OF WORK

Hereunder follows an outline of the scope of work for the above-mentioned services:-

3.2 Objectives of the project

The winning bidder or the appointed service provider will be expected to deliver the following deliverables within a period of 4 months as of the appointment date:-

- Provide a concrete statement about the status quo of EMIS data quality
- Provide improvement recommendations and solution concept for optimizing the quality of the data at short term and maintaining the level achieved in the long term
- Identifying potential process-optimizing opportunities
- Provide an overview of possible saving potential in running EMIS data collection processes.

3.3 Project Outcomes

The service provider is expected to conduct data quality audit in 247 of our entities (institutions) in Limpopo as tabulated in paragraph 2 above. The audit must provide a detailed account of the following:

- a) Data creation and processing procedures.
- b) Headcount of Learners, including verification of manual attendance registers and admission registers
- c) Usage, Quality and level of completeness of all modules in SA-SAMS
- d) Entire data collection cycle and its limitations. This will among others includes the roles of the various officials at Schools, Circuits, Districts, and Head Office in data processing.
- e) Implementation of various EMIS related policies in the entire data value chain at Schools, Circuits, Districts and Head Office.

3.4 Project Deliverables

3.4.1 Phase 1: Generation of Audit Instrument and Sample by the Successful Bidder

- a) The successful bidder is required to generate a sample that is representative of the entities in the Department. NB: The final sample list of the entities to be audited will be agreed with the Successful Bidder during the signing of Service Level Agreement (SLA).

- d) The objectivity of the audit process will be given priority in all levels.

3.4.2 Phase 2: Capturing of data and findings

- a) The service provider will capture, record and report all data findings using tools that are compatible with the current information systems within the department.
- b) All data assembled in the way of the DQA will need to be handed over to the department following the completion of the audit process.

3.4.3 Phase 3: Report writing

- a) It is expected of the service provider to compile a detailed report on the DQA process guided by the objectives and deliverables of the project.
- b) The service provider is required to table the report at a joint meeting with the project sponsors.

4 EVALUATION CRITERIA

The bid will be evaluated in three phases, namely:

Stage 1: Administrative Compliance

Stage 2: Functionality evaluation criteria

Stage 3: Highest point scoring bidders will be appointed (pricing & BBEE).

4.1 Administrative Compliance

- 4.1.1 Where reference is made in the bid document to the terms, 'firm', 'tender' and 'bidder', it should be noted that they refer to one and the same name.
- 4.1.2 In the event the trade name is different from the legal name, the trade name must be used as the name of the bidder and NOT the legal name.
- 4.1.3 Naming of the bidding company must be consistent in the request for bid (RFB) document; Central Supplier Database and business entity registration documents.
- 4.1.4 If the name of the bidder on Central Supplier Database and business entity registration document ends with a 'cc', 'PTY/LTD, etc., or it does not, it is expected that the name of the bidder as written in the RFB document will read 100% the same, that is, ending or not ending with 'cc', PTY/LTD, etc., whichever is the case. Deviations to this pre-requisite will disqualify the bid.
- 4.1.5 All SBD Forms should be completed. Failure to complete and sign the SBD forms shall lead to disqualification of the bid:
 - SBD 1: Invitation to bid
 - SBD 4: Declaration of interest
 - SBD 6.1: PPPFA claim form i.t.o. the Preferential Procurement Regulations 2011
- 4.1.6 SBD forms will be signed for each task order allocation by a selected service provider. Bidders are required to declare interest if owning more than one company.
- 4.1.7 The documents listed below should be attached to the RFB document. Failure to attach the document shall invalidate (disqualify) a bid offer:
 - a) Business entity registration documents;
 - b) Valid Broad-Based Black Economic Empowerment Status Level
 - c) Verification Certificate or an original sworn Affidavit as per companies and intellectual property commission
 - d) Certified copy or copies of ID / Passports of MEMBERS/SHAREHOLDERS (not copy of a certified copy). The certified copy must not be older than six months from closure of the bid) of the members if cc, partners in a partnership, directors of private/public company and owner if a sole trader;
 - e) Bid documents have been properly signed and completed in the original ink and in handwriting. No copies of completed bid documents will be accepted. All Standard Bidding Documents should be returned in its original form;
 - f) Alterations/corrections must be struck through and signed. The use of erasing fluid and erasers is prohibited

- g) When submitting a bid document, bidders are advised to enclose a PDF copy of the completed bid document and mandatory attachments on a CD/soft copy marked with the company's name, bid number and bid description

4.1.8 In case of a joint venture, each company to submit separately, a fully completed proposed rates per item in the attached bills of quantities.

4.1.9 Any alteration to the bid document will lead to disqualification.

4.2 Functionality

4.2.1 The service provider is required to develop a costed audit proposal as part of the bidding process and must include among others, the following:

- a) The understanding of the project from the bidders' perspective. This will include, among others, project objectives and related deliverables
- b) The methodology to be used and a detailed description (**methodology**) of how the project will be approached using that methodology. The methodology should be an industry-developed best practice in Data Quality Audit.
- c) The proposal must include clear roles and responsibilities of all project team members and their related qualifications – (*evidence of qualifications is required*)
- d) Project plan with clear management plan, project schedule and related costs
- e) Experience (*including evidence of contactable reference*) of the bidder in conducting Data Quality Audit projects

4.2.3 A bidder that fails to score **75** points in respect of functionality will be deemed to be non-responsive and will not be considered for further evaluation.

4.3 Price and B-BBEE Status Level of Contribution

The bid will be awarded on 80/20 point scoring system and claiming of preference points.

5 SPECIFIC CONDITIONS OF THE BID

5.1 Price

5.1.1 Bid price must be in RSA currency and VAT inclusive.

5.1.2 The bid must include clear breakdown cost per each resource.

5.1.3 Bid price shall be firm for the duration of the contract.

5.2 Payments

- ~~5.2.1 The service provider shall submit invoices of the services provided accompanied by the LDoE approved time sheets, indicating the services provided as per the agreed upon project plan and the costing as stipulated and accepted under the bid to the Department.~~
- 5.2.2 No advance payment will be made. Payment will be made in terms of the completed deliverables as per the agreed project plan unless otherwise agreed upon by other parties (LDoE and the contractor). LDoE will pay within the prescribed period according to PFMA.

5.3 Communication

- 5.3.1 The service providers are expected to indicate their telephone numbers, fax numbers, cellular or any means of communication in the Bid **Document**.
- 5.3.2 Any changes of contact details must be communicated in writing to the department.
- 5.3.3 There will be no compulsory clarification meeting

5.4 Delivery Time-Frames

- 5.4.1 The project should be completed within four months period after the signing of Service Level Agreement between LDOE and the service provider. It is estimated that the audit will be concluded before the end of March 2022.
- 5.4.2 The details of the processes, timeframes and deliverables will again be outlined in a service level agreement that will be signed with the successful bidder.
- 5.4.3 When deadlines are set, it will be expected of service providers to deliver the required services/goods in a set timeframe, provided that such instructions are issued timeously.

5.5 Termination of Contract

- 5.5.1 The Department reserves the right to terminate the contract in the event the successful bidder violates or fails to comply with one or more of the conditions stipulated in the bid conditions.
- 5.5.2 Should the service provider fail to perform duties as per contractual expectations within the period mentioned above without valid reason, the department reserves the right to cancel the order and appoint another service provider. The onus lies with the service provider to explain, in writing to the department why he or she cannot comply with contractual obligations within the stipulated time frame.
- 5.5.3 The Department does not hold itself liable for any consequential damages, which may arise from such cancellation of the bid.

5.6 Eligibility Criteria

Only those bidders who satisfy the following eligibility criteria and who provide the required evidence in their bid submissions are eligible to submit bids and have their bids evaluated.

- 5.6.1 The service provider should have knowledge of the Government performance information legislation, framework and policies. The service provider, as well as the project team, responsible for the project, should have the relevant qualifications and extensive experience in relation to conducting Data Quality Audit. The successful service provider should ensure that the resources targeted for this project have the necessary knowledge, skills and experience to successfully undertake above mentioned specification.
- 5.6.2 In case of a Joint Venture/Consortium submission, shall submit a certified copy of a Joint Venture agreement signed by all authorized parties. No copies of the agreement will be accepted.
- 5.6.3 Is registered in terms of the Companies Act, 2008 (Act 71 of 2008) or Close Corporation Act, 1984, (Act No. 69 of 1984) or, if a partnership, has a partnership agreement (buy and sell agreement for participating partners in this bid) in place that enables the partnership to automatically continue to function in the event of death or withdrawal of one of the partners.
- 5.6.4 None of the documents with correction fluid on them. Any wrong entry, in case of correction, it must be cancelled by a single stroke and initialed by the authorized signatory.

6 OBLIGATIONS:

6.1 Department of Education

The Department shall immediately communicate with the successful service provider on any matter, defect or deficiency detected during the contract period.

6.2 The service provider/bidder

- 6.2.1 The bidder shall perform the services in accordance with the conditions of bid specifications.
- 6.2.2 The bidder (contractor) may not cede his/her bid (contract) to a third party without prior written approval of the Head of Department or his delegate.

6.3 General Conditions of Contract

The bidder shall be subjected to compliance with the **General Conditions of Contract**.

7 RESERVATION OF RIGHTS

~~The Department reserves the right to:-~~

- 7.1 Communicate only with the shortlisted bidders as and when necessary;
- 7.2 Request further information from any bidder after the closing date of the bid;
- 7.3 Verify information and documentation of respective bidders from the South African Revenue Services, Companies and Intellectual Property Commission or any other relevant entity and to visit the premises of the bidder at any time without notice. Any information received which does not correspond with the one provided in the bid document will render the bid null and void;
- 7.4 Appoint a third party to evaluate the Successful Bidder's compliance with any aspect of this bid including inspection of the premises;
- 7.5 Award the bid to a bidder who did not score the highest points or not make an award;
- 7.6 Terminate the contract, if the Department is satisfied that any person (being an employee, partner, director or shareholder of the bidder or a person acting on behalf of or with the knowledge of the bidder), firm or company (The expression "person, firm or company" shall include an authorized employee or agent of such a person, firm or company): -
 - 7.6.1 is executing a contract with government unsatisfactorily;
 - 7.6.2 has offered, promised or given a bribe or other gift or remuneration to any officer or employee in the Public Service in connection with obtaining or executing a contract;
 - 7.6.3 has acted in a fraudulent manner or in bad faith or in any other unsatisfactory manner in obtaining a contract with any government department, provincial administration, public body, company or person, or that he has managed his affairs in such a way that he has in consequence there-of been found guilty of a criminal offence;
