REQUEST FOR PROVISION OF SUPPLY OF NEW THEODOLITE, STAND AND CARRY BAG.

1. PURPOSE:

The purpose of this service request is to invite quotations for provision of new theodolite, stand and a carry bag.

2. BACKGROUND:

GAAL seeks to appoint the services of reputable Service Provider for the provision of a new theodolite.

It is a requirement with Polokwane International Airport Aerodrome Manual that the PAPI lights will be verified monthly to confirm compliance. Civil Aviation Regulation (CAR) 139.02.23(1) which states that: A holder of an aerodrome license shall – (b) comply with all procedures detailed in such approved manuals.

3. REQUIRED SERVICES

The services required are as follows:

- ❖ Provision of a new theodolite plus stand and carry bag.
- ❖ Theodolite should be relevant to verify the Precision Approach Path Indicators (PAPI) light at the airfield as required by South African Civil Aviation Authorities requirements.
- ❖ Description magnification 30x and LCD on both sides (electronic theodolite with optical plummet or laser plummet, appropriate for measurements in the field of surveying, railway, construction, mining and engineering, equipped with tubular and circular bubble for quick level up, switchable between Grad, Gon and mil.

- ❖ Scope of delivery: Instrument, manual, battery charger, battery, battery compartment for 4x AA batteries, tool kit, rain cover, transport case with carrying strap and tribrach.

4. EVALUATION CRITERIA

All quotations will be evaluated in terms of administrative requirements and preference point system.

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such

cancellation;

- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
