1. Intent

The intent of this RFQ is to outline the scope of work and specifications for the Supply, Delivery and Installation of chemicals, a chemical dosing pump, and routine service for the existing Hood-Type Dishwasher for a period of 24 months to iThemba LABS, Old Faure Road, Faure, Canteen.

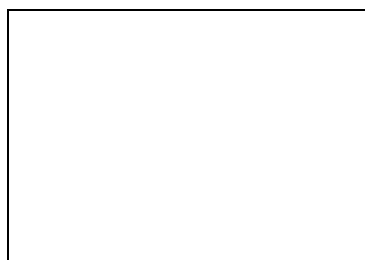
