PURPOSE

The Kwazulu-Natal Growth Fund Agency (KZNGFA) invite quotations from suitably qualified and experience service providers to do the Office Space Design for the new Office Space that KZNGFA will occupy.

1. BACKGROUND

KZN Growth Fund (KZNGFA) is an Agency, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KZNGFA is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KZNGFA, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development, and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KZNGFA Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KZNGFA.

The KZNGFA wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

2. SCOPE OF WORK

KZNGFA requires service provider to undertake the below at its new proposed office premises situated at Kingsmead Office Park. KZNGFA will be occupying two (2) floors namely the 3rd and 4th floor. The estimated size of the offices is 1353m².

- Interior designs for office look and feel and selection of interior design elements per the approved plans. Designs must consider cost efficiency and sustainability principles and incorporating eco-friendly design elements where feasible.
- Provide design drawings, Graphic designs.
- Create space for pause area in the existing structure/space

- Frosting of all offices and boardrooms doors as per the layout
- Draft specification for the procurement of furniture and fittings and manage the delivery and installation of furniture and fittings.
- Collaborate with the IT department with respect to IT and Security installations for the office space.
- Project manage the remodelling work and all associated activities from start to occupation as well as resolving any post occupation snags.

3. CONTRACT DURATION

The Services will be provided over a 4 (four) month period.

4. AWARD OF THE RFP

KZNGFA is not obliged to accept and award this tender to the lowest bidder or any other bidder.

5. EVALUATION PROCESS AND CRITERIA

Selection will be conducted over three stages as detailed below:

Stage 2 - Functionality

Stage 3 – Price and Specific Goals

9.1 STAGE 1 – COMPLIANCE WITH MANDATORY REQUIREMENTS

All bids duly lodged as specified in this RFQ will be examined to determine compliance with the mandatory requirements and conditions. Failure to provide any mandatory information as requested above will results in the submission being deemed non-responsive.

9.2 FUNCTIONALITY EVALUATION

Scores will be tabulated to 100 points. Respondents must score 70 points and over to be assessed on their financial offer and preference score.

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
