South African National Parks invites tenders for **Corrective maintenance & renovations on infrastructure in Kgalagadi Transfrontier Park for a period of 3 years, Northern Cape**

SANParks invites prospective bidders for the Corrective maintenance & renovations on infrastructure in Kgalagadi Transfrontier Park for a period of 3 years.

The following tenderers who are registered with the CIDB, or are capable of being so registered prior to the evaluation of submissions are eligible to submit tenders:

ELIGIBILITY

1) CIDB Grading

- a) It is estimated that tenderers must have a CIDB contractor grading **5 GB** or higher.
- b) Joint ventures are eligible to submit tenders provided that:
 - i) every member of the joint venture is registered with the CIDB
 - ii) the lead partner has a contractor grading designation in the **5 GB** class of the construction work
 - iii) The combined contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered of 5 GB class of construction work or a value determined in accordance with the Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations.
- c) Only tenderers who comply with the following are eligible to submit tenders:
 - Have the required and valid CIDB grading stated.
 - Achieved the minimum score for Functionality
 - Tenderer is not listed in the Register of Tender Defaulters and prohibited from doing business with the public sector.
 - The tenderer has not abused the Employer's supply chain management system
 - The tenderer has not failed to perform on any previous contract with the employer.
- d) Joint ventures are to submit JV B-BBEE Level Status verification certificates.

A **compulsory clarification meeting** with representatives of the Employer will take place at **The Boardroom, Administration Building, Twee Rivieren, Kgalagadi Transfrontier Park on 26 June 2024** starting at **11:00 hrs**. Site visits to the 3 main rest camps will be conducted on the following dates:

26 June – Twee Rivieren (directly after the clarification meeting)

27 June – Mata Mata and Nossob (departure from Twee Rivieren at 8h00)

It is suggested that 1 night's accommodation is secured at Twee Rivieren Rest Camp inside the Park, as departure to the Mata Mata and Nossob sites will be at 8h00 on 27 June. **Accommodation for the bidder's account.**

Tender documents will only be available on the **26 June 2024** at the compulsory site clarification meeting. **SANParks representative will only sign the Site Clarification Attendance in the tender document on 27 June 2024 after the final site visit. Tenders submitted without the signature of the SANParks representative will be deemed non-responsive, disqualified and eliminated from the evaluation process.**

The tender document is issued at a non-refundable fee of **R300.00 cash only**. No EFT facilities available.

The physical address for the compulsory clarification meeting and collection of tender documents is: **The Boardroom, Administration Building, Twee Rivieren, Kgalagadi Transfrontier Park, Northern Cape.**

The Tenderers shall inspect and examine the Site and its surroundings and shall satisfy themselves before submitting their tender as to the form and nature of the Site, the quantities and nature of the work and materials necessary for the completion of the Works and the means of access of the Site, the accommodation they may require and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their tender.

The tenderers must be represented at the site inspection by a person who is suitably qualified and experienced to comprehend the implications of the work involved. Attendance of the site inspection is compulsory and a tender will be disqualified if the site inspection is not attended by a representative of the tenderer.
